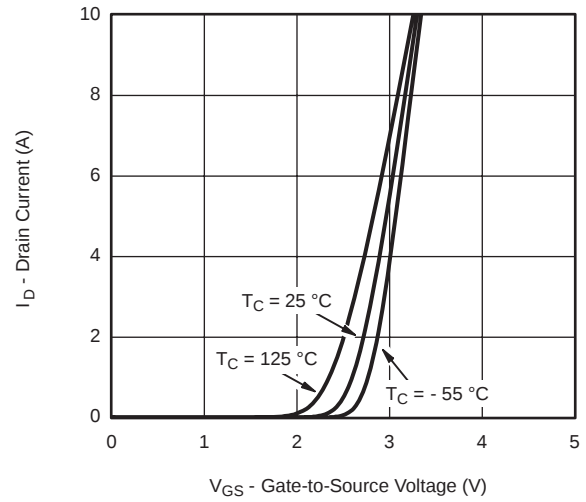

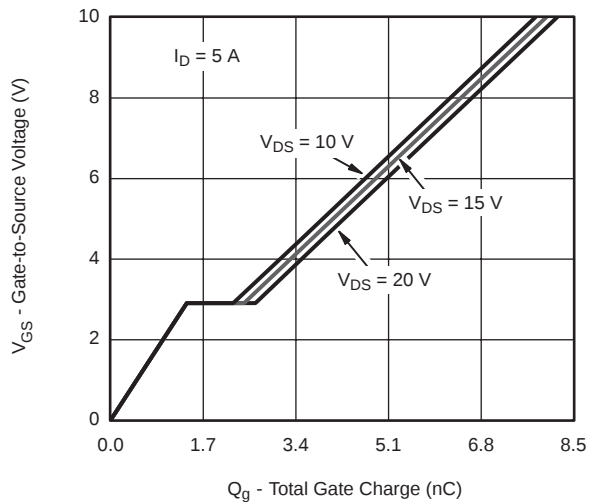

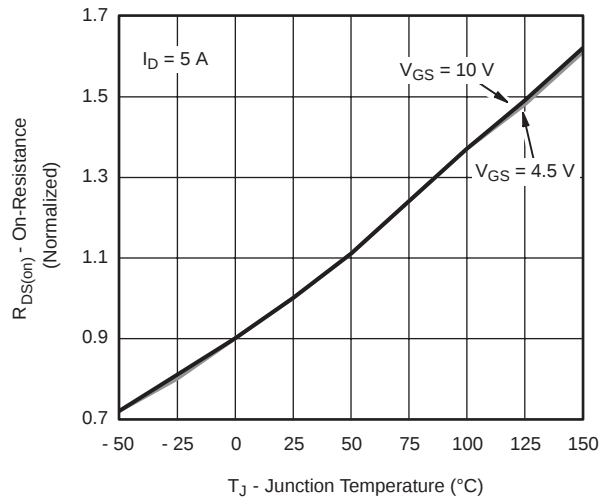
On-Resistance vs. Drain Current

Figure 10 is a line graph showing the variation of $V_{GS(th)}$ (V) on the y-axis versus T_J - Temperature ($^{\circ}C$) on the x-axis. The y-axis ranges from -1.0 to 0.5 V, and the x-axis ranges from -50 to 150 $^{\circ}C$. Two curves are plotted, representing different drain currents I_D :

- The solid black line represents $I_D = 5 \text{ mA}$.
- The solid grey line represents $I_D = 250 \mu\text{A}$.

Both curves show a negative linear relationship between $V_{GS(th)}$ and temperature. The $I_D = 5 \text{ mA}$ curve has a steeper negative slope than the $I_D = 250 \mu\text{A}$ curve.

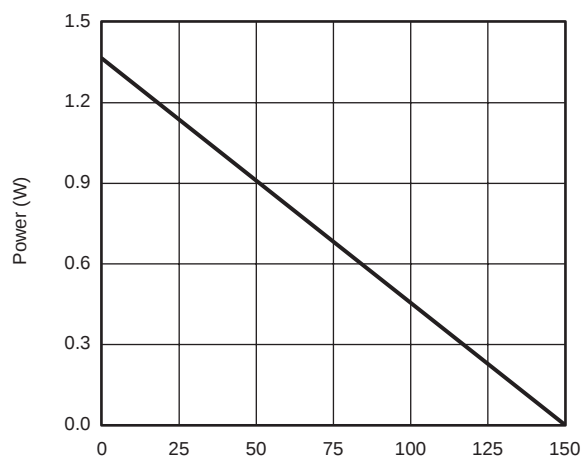
