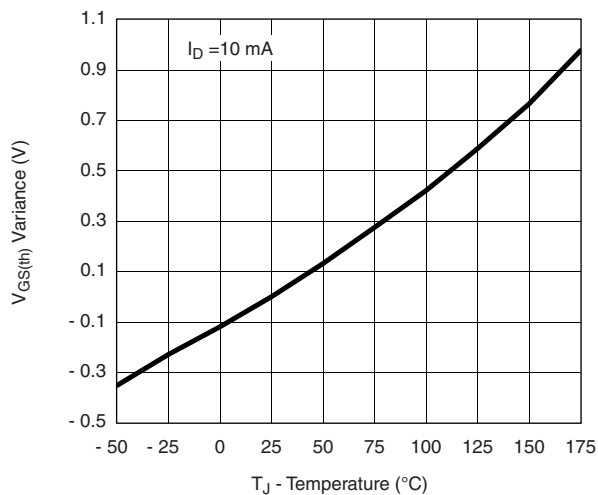

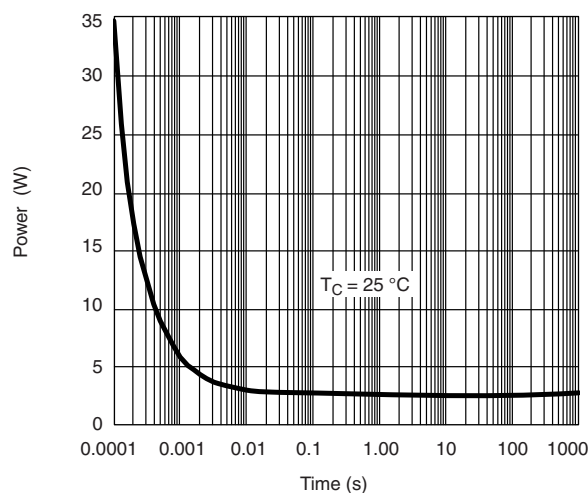
Source-Drain Diode Forward Voltage



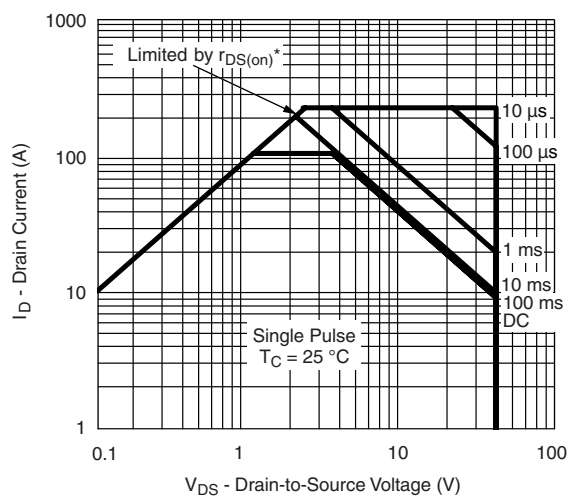
On-Resistance vs. Gate-to-Source Voltage



Threshold Voltage



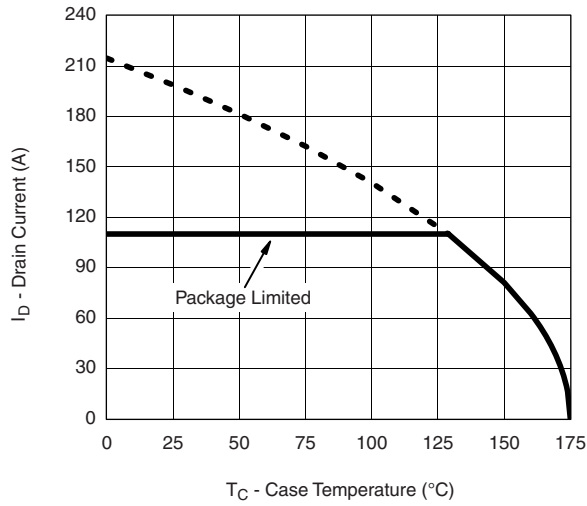
Single Pulse Power, Junction-to-Ambient



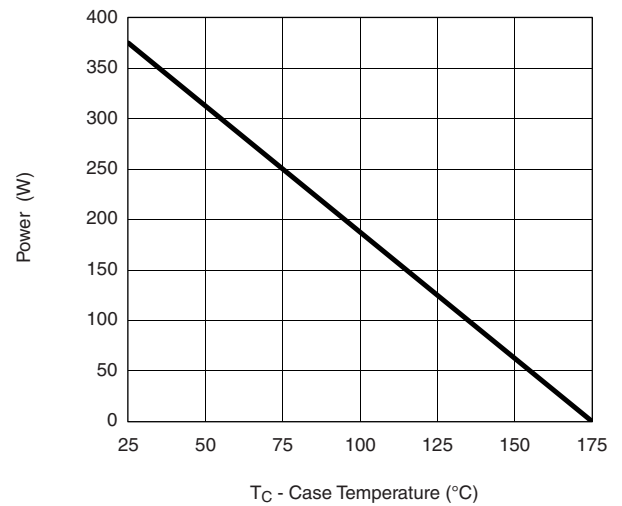

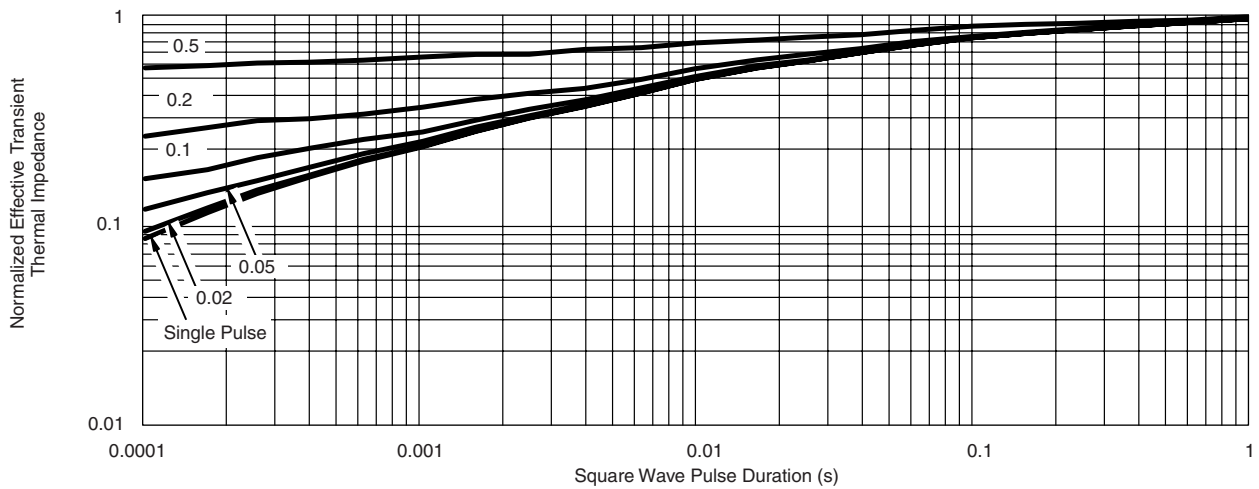

Max. Avalanche and Drain Current vs. Case Temperature*



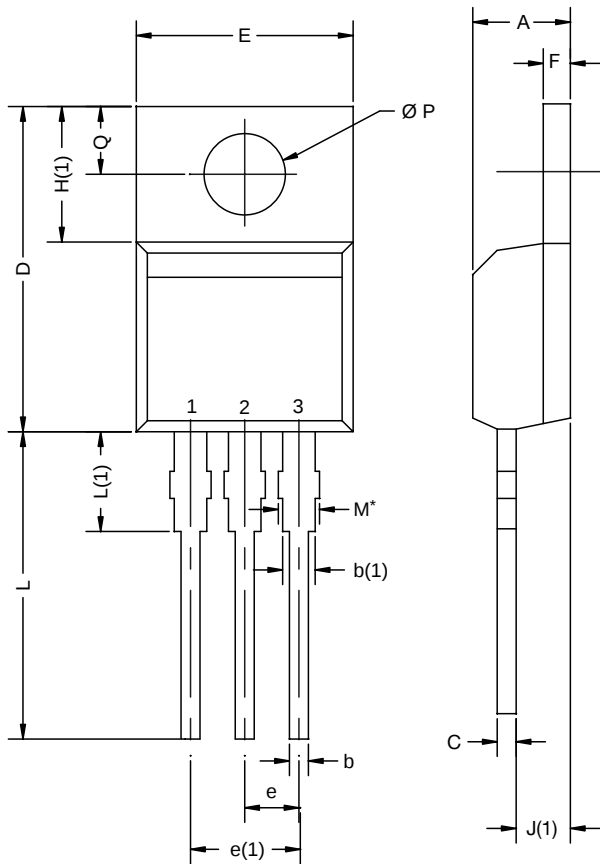
Power Derating, Junction-to-Case
