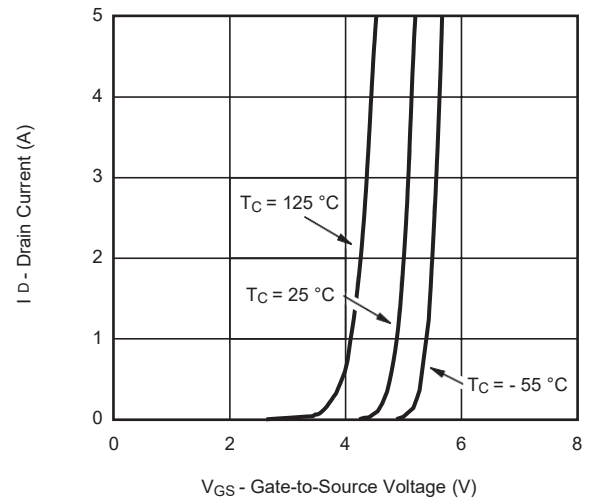

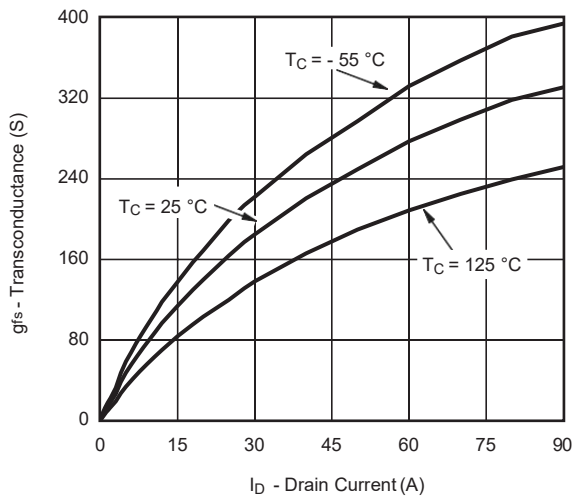
TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



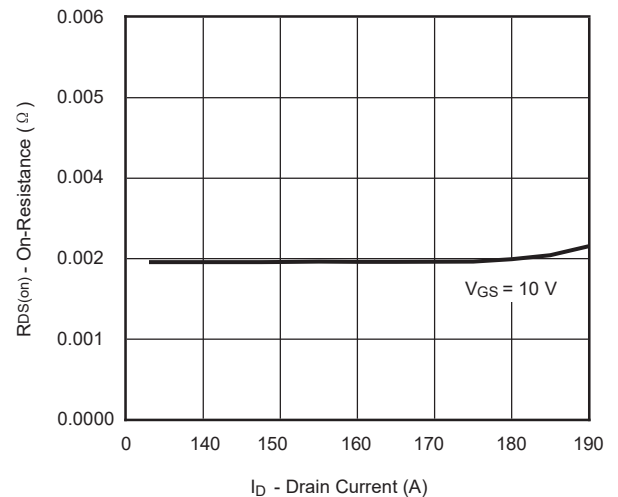

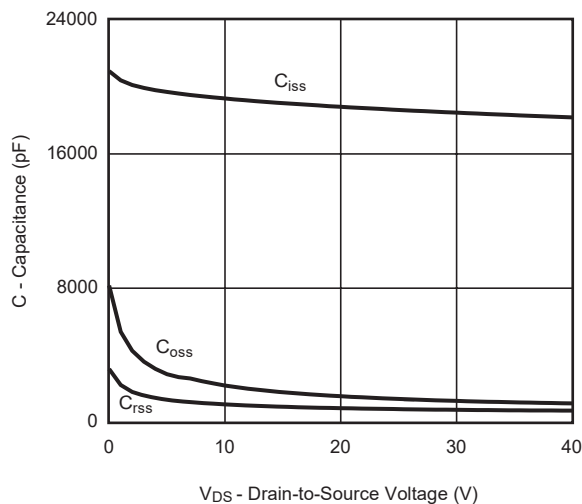
Transfer Characteristics



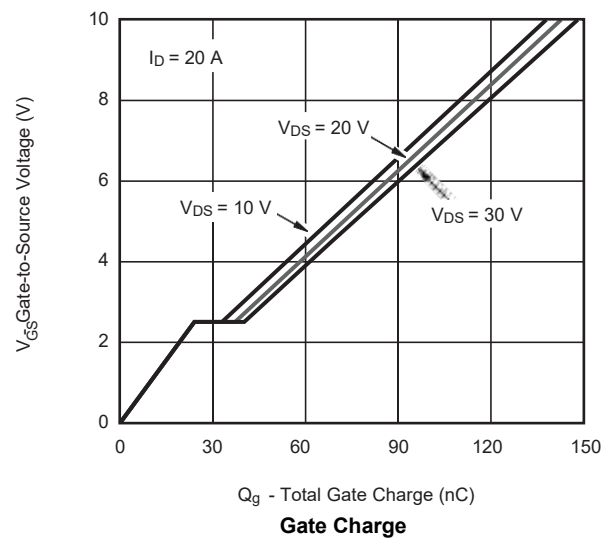
Transconductance

On-Resistance vs. Gate-to-Source Voltage



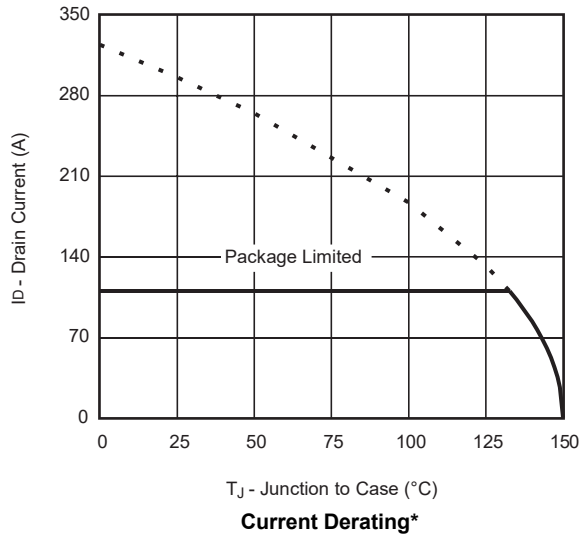

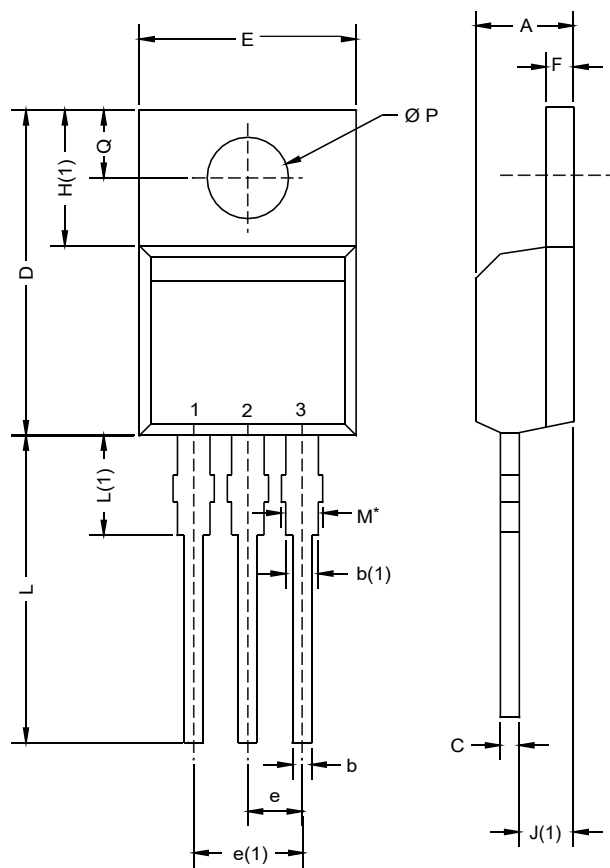
