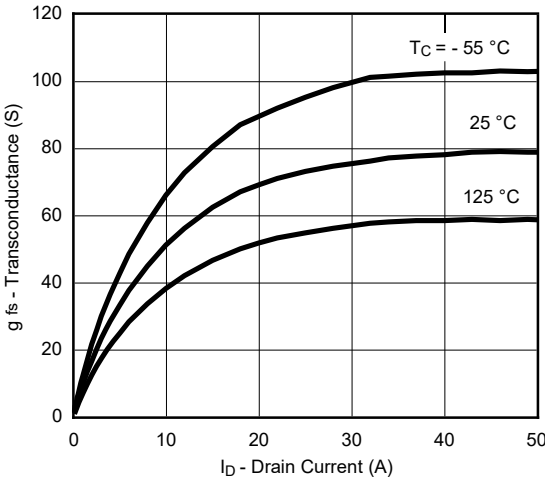

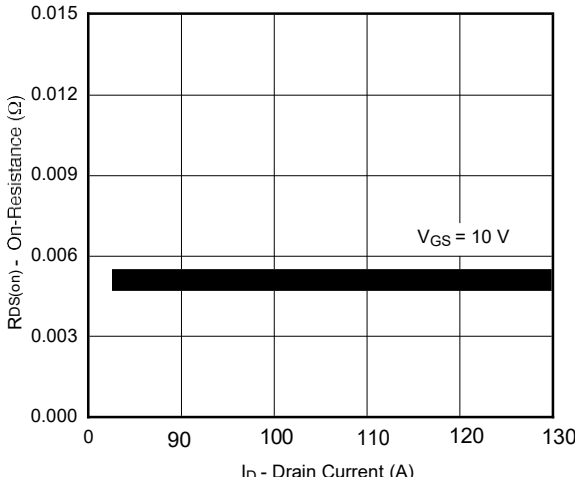

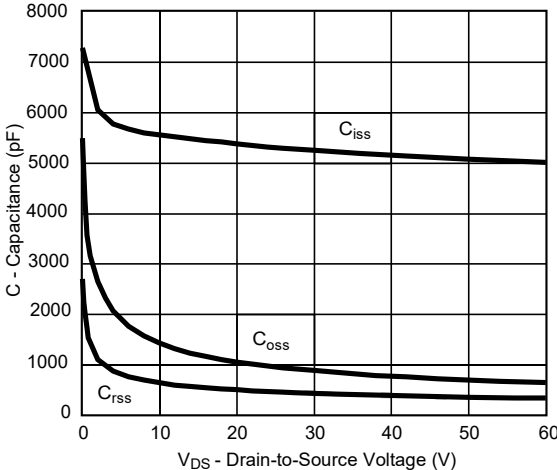

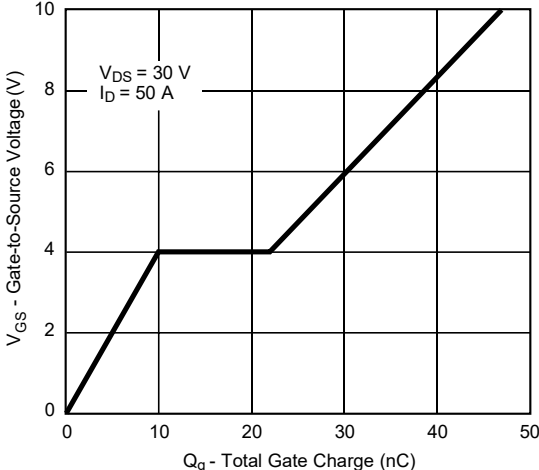
Transconductance

Capacitance

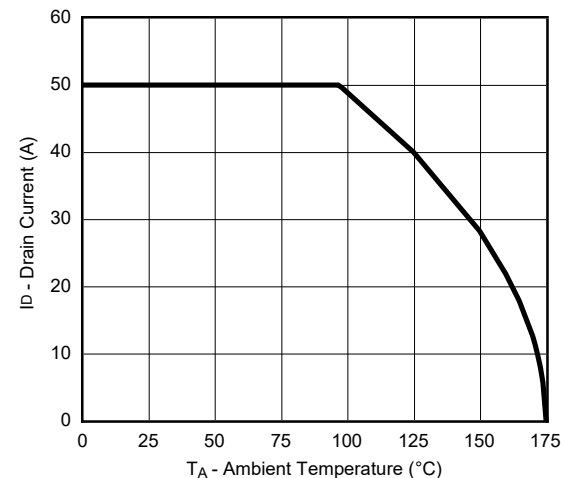

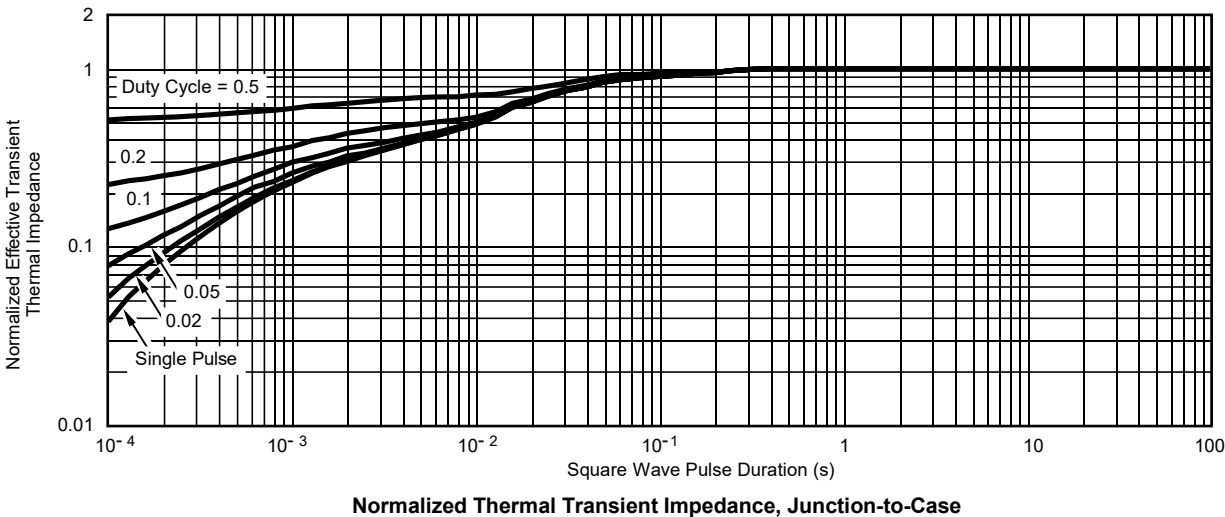
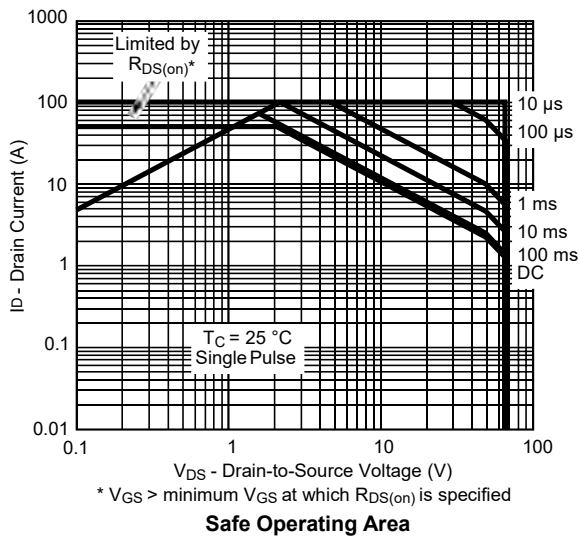
