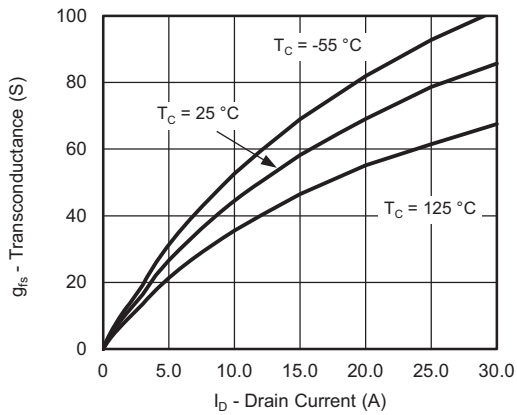

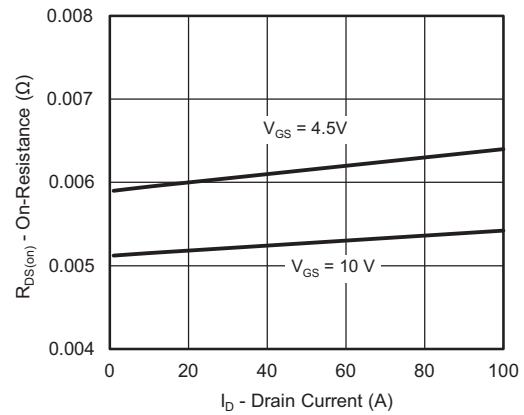

On-Resistance vs. Drain Current

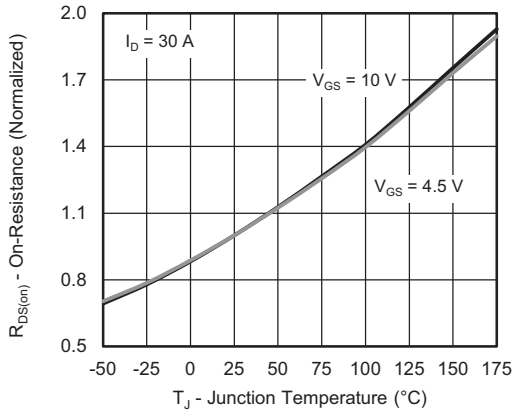

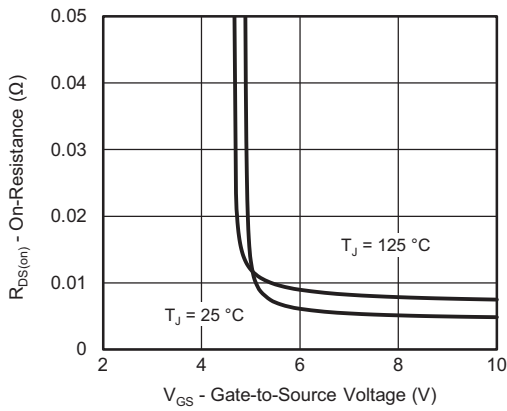

On-Resistance vs. Junction Temperature



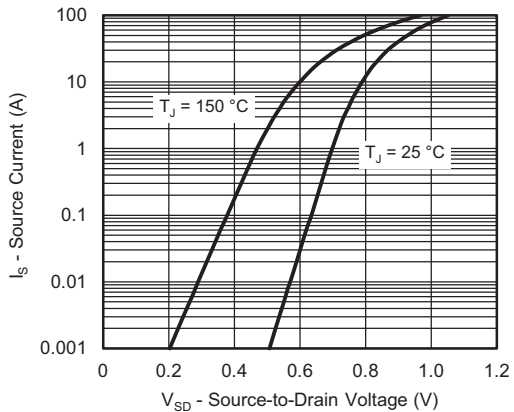
Threshold Voltage

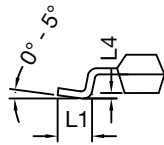

Normalized Thermal Transient Impedance, Junction-to-Case

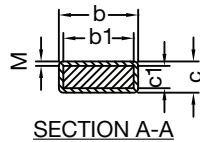

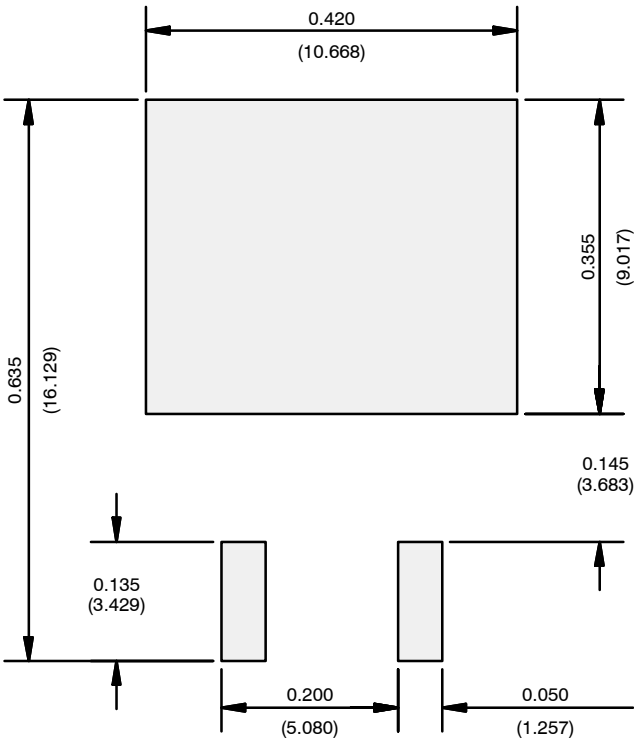
