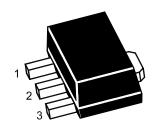

1. VOUT 2. GND 3. VIN

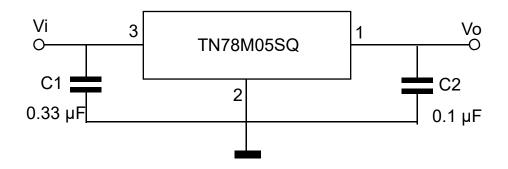

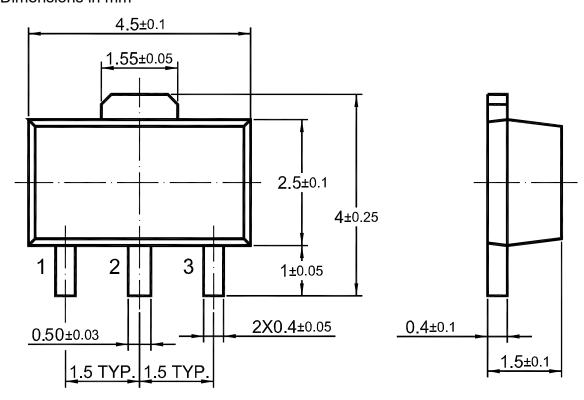
