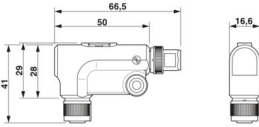

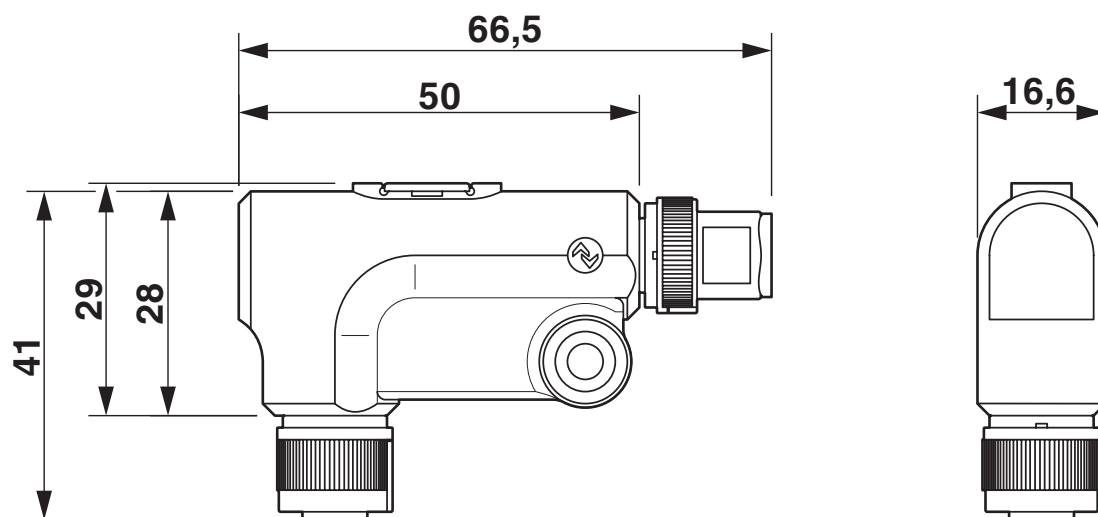

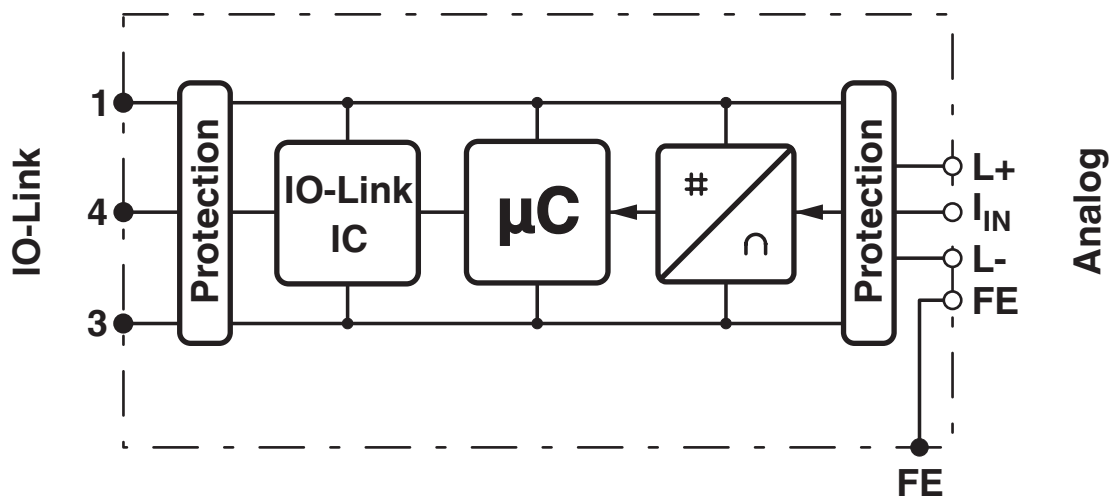

Block diagram



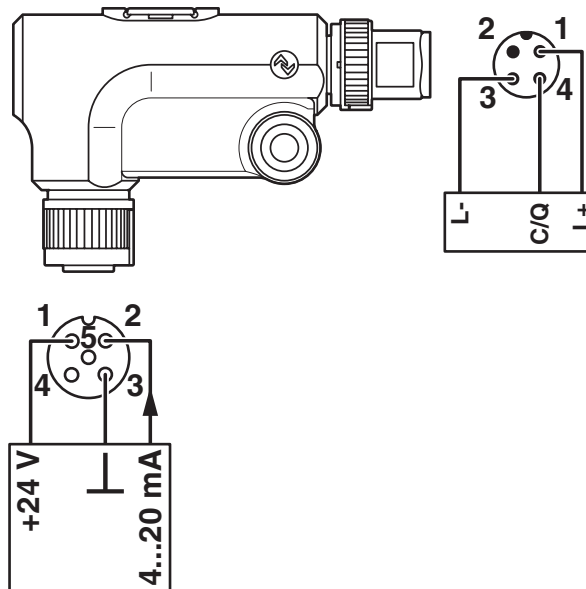
