1. General description

The 74CBTLV1G125 provides a single high-speed line switch. The switch is disabled when the output enable ($\overline{\text{OE}}$) input is high.

To ensure the high-impedance OFF-state during power-up or power-down, tie $\overline{\text{OE}}$ to the V_{CC} through a pull-up resistor. The current-sinking capability of the driver determines the minimum value of the resistor.

Schmitt trigger action at control input makes the circuit tolerant to slower input rise and fall times across the entire V_{CC} range from 2.3 V to 3.6 V.

This device is fully specified for partial power-down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.

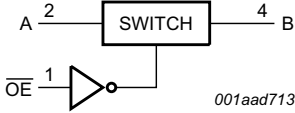


Fig 1. Logic symbol

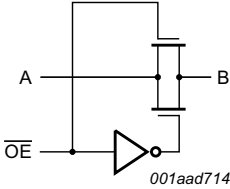
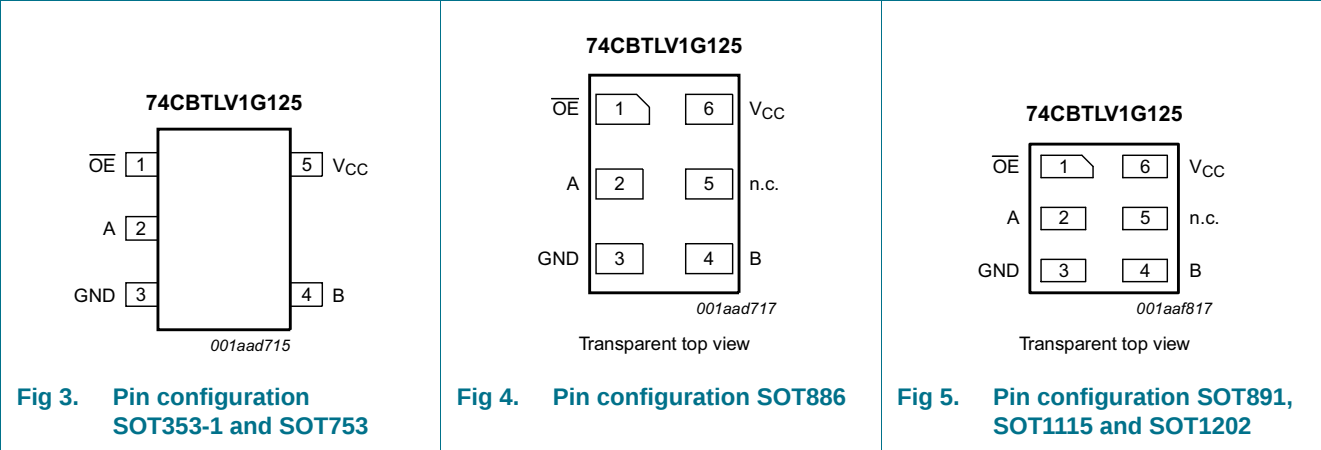


Fig 2. Logic diagram

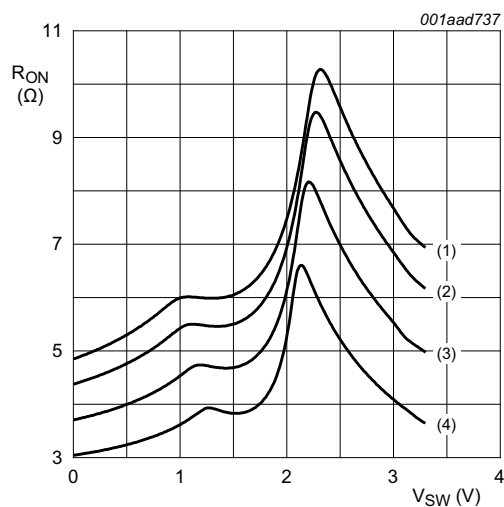

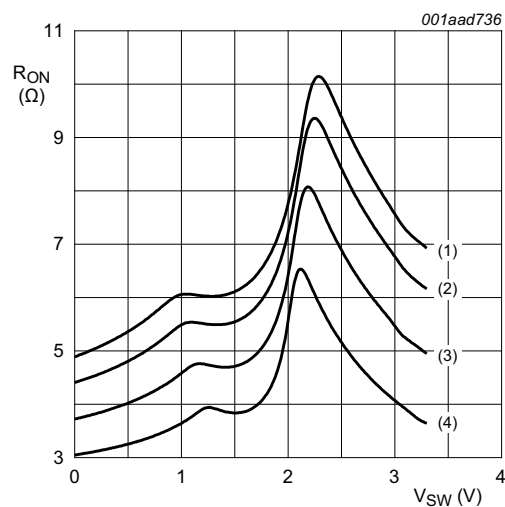

Fig 9. Switch ON-resistance as a function of input voltage at $V_{CC} = 2.5\text{ V}$



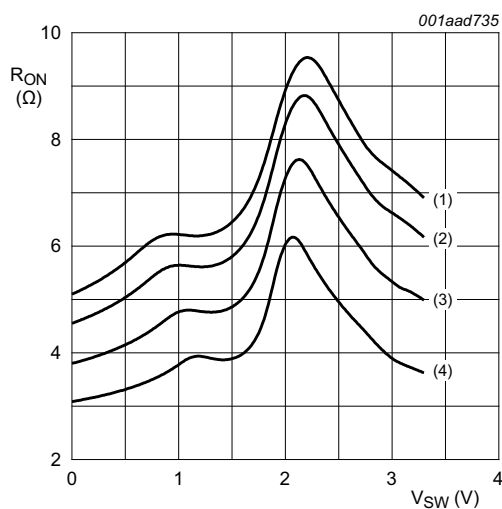

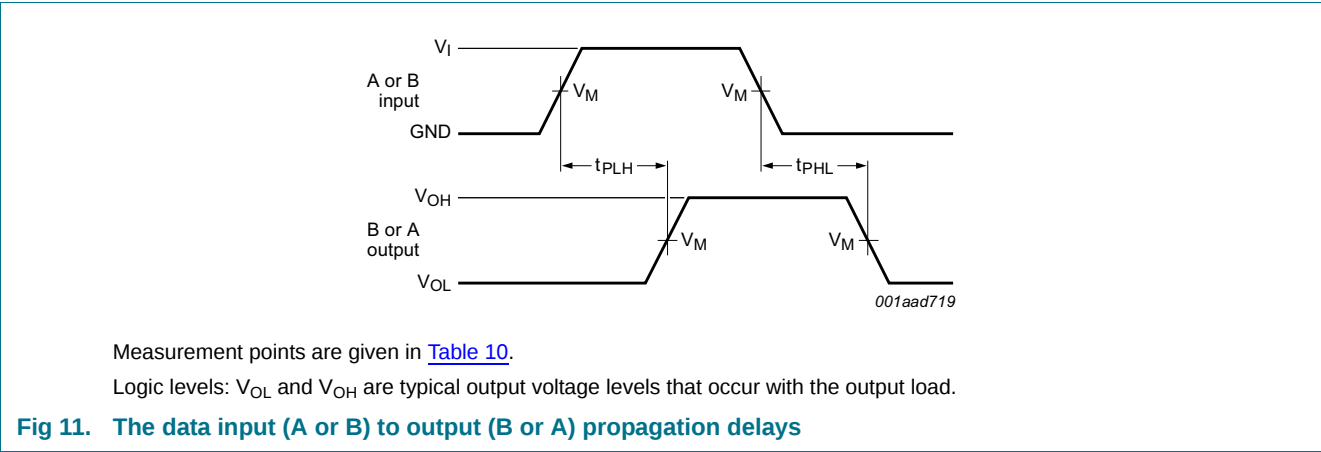
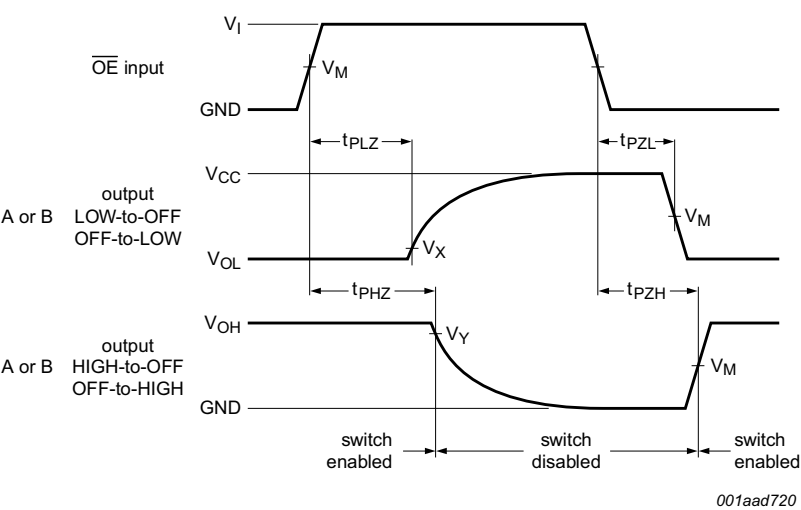

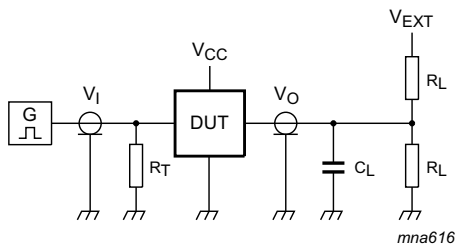

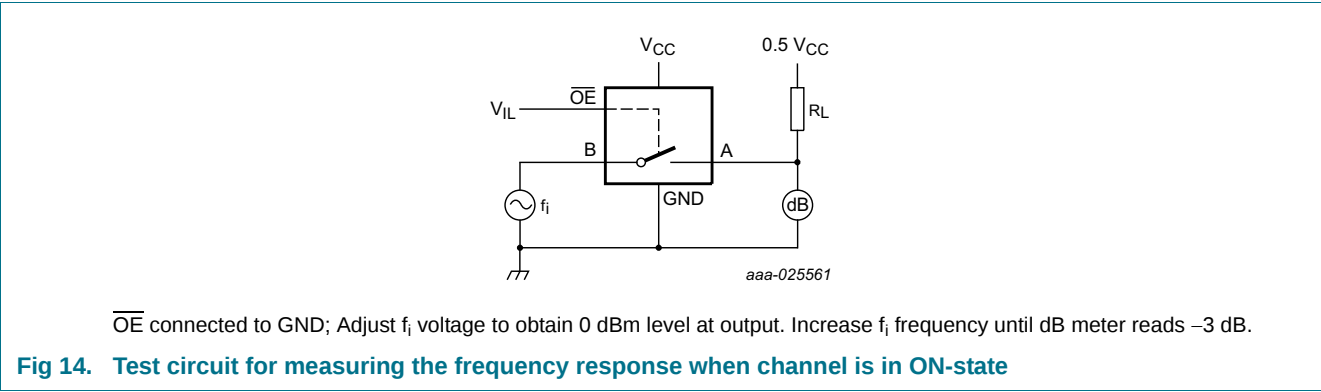

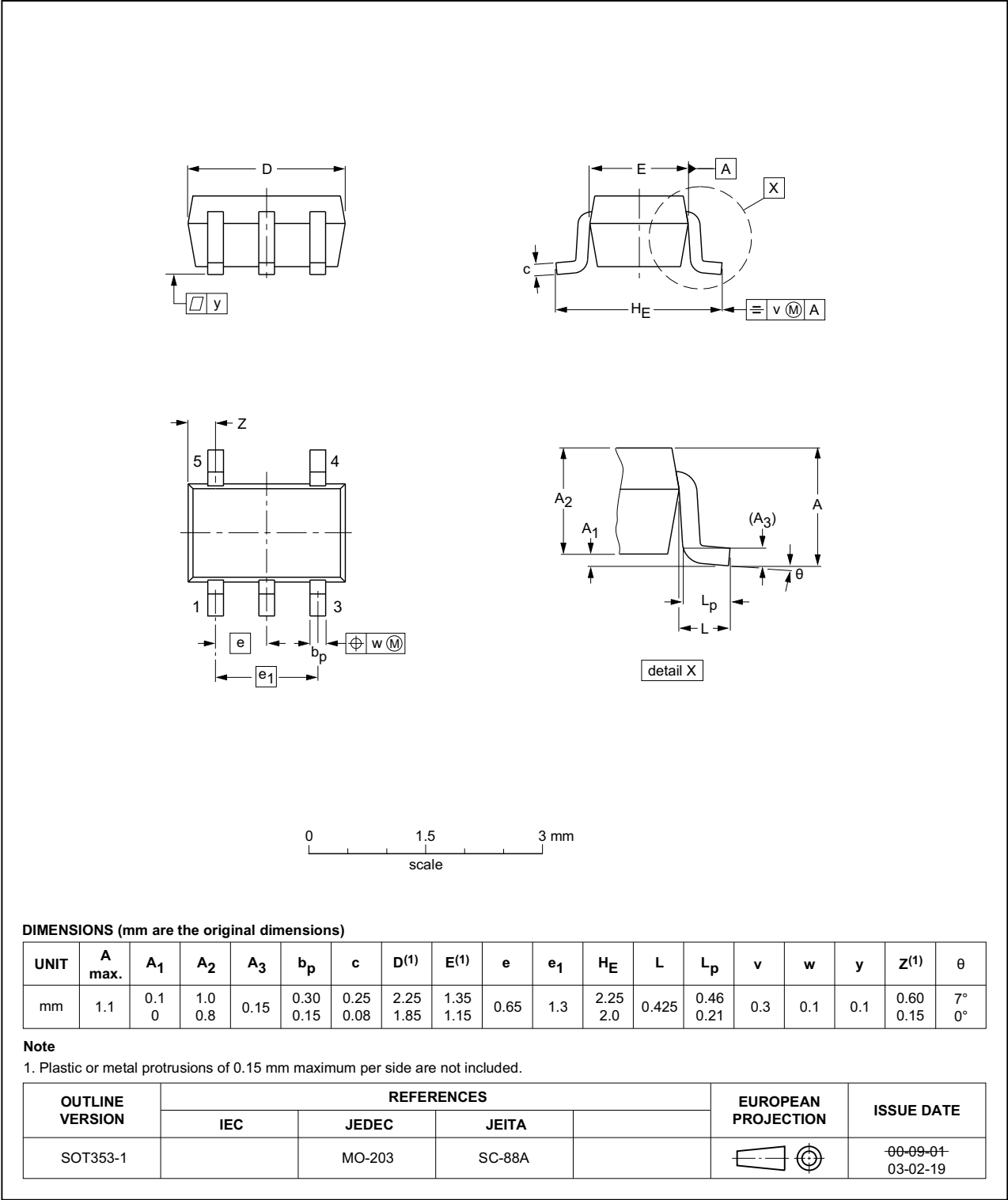


Fig 15. Package outline SOT353-1 (TSSOP5)

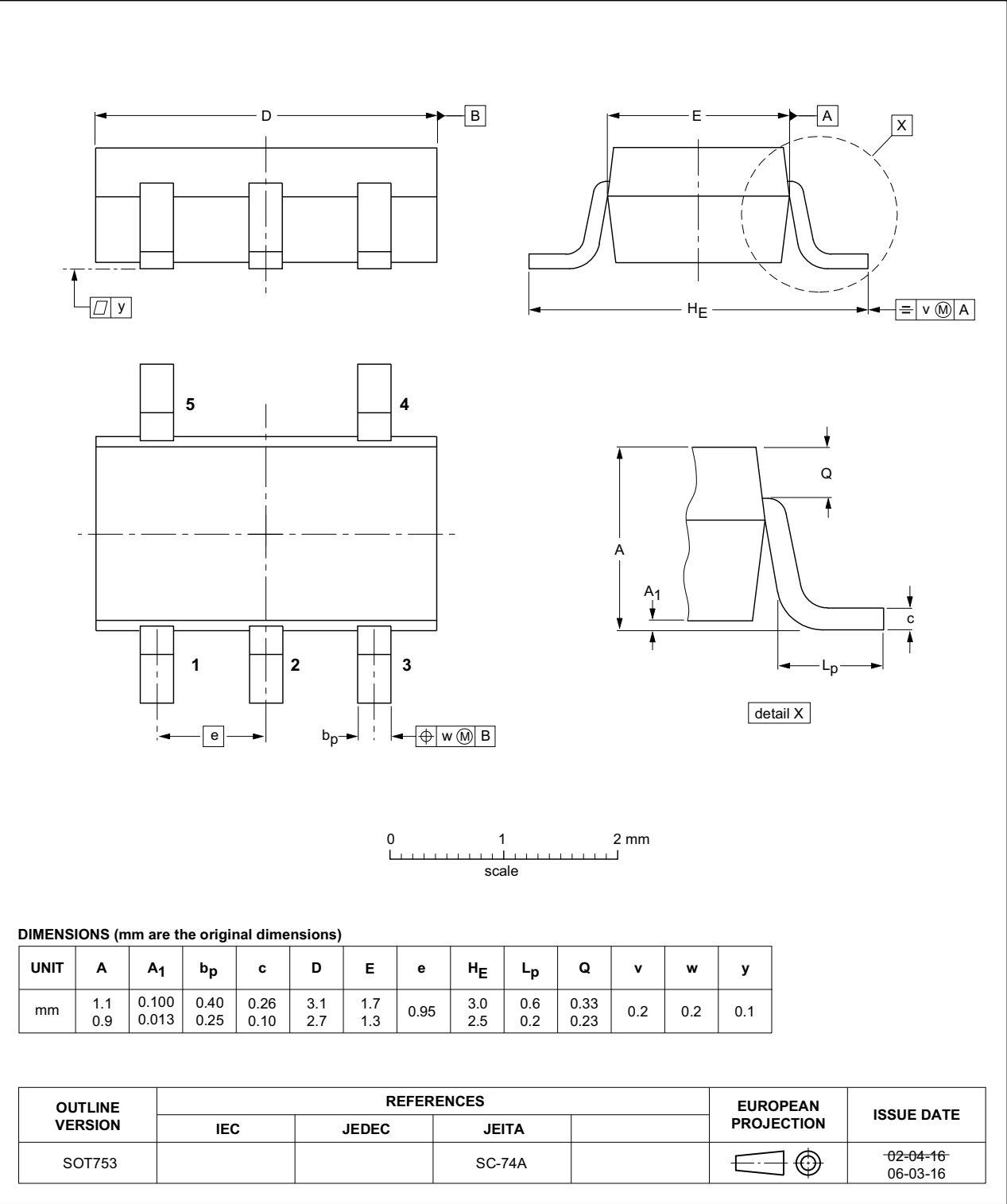


Fig 16. Package outline SOT753

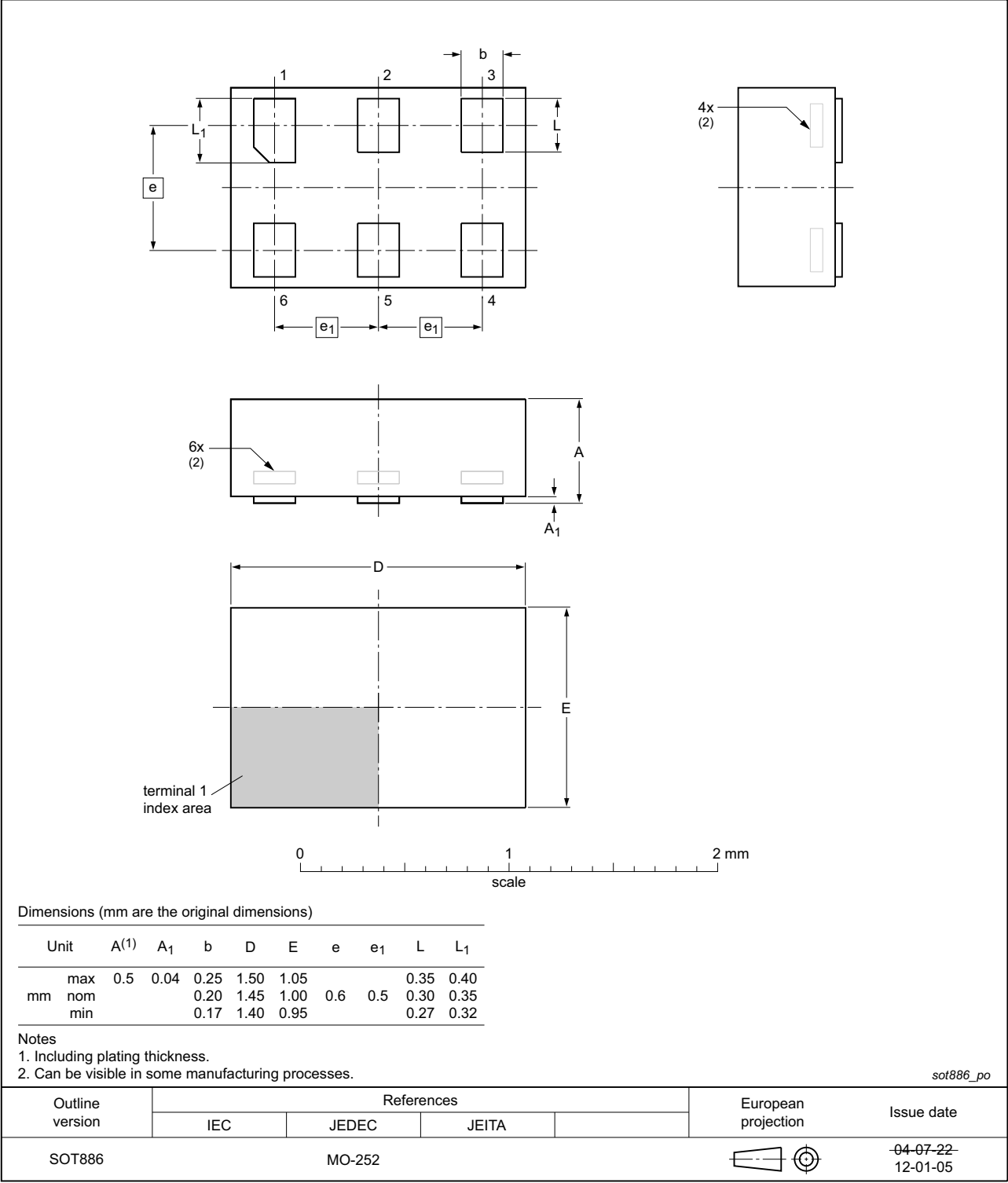


Fig 17. Package outline SOT886 (XSON6)

XSON6: plastic extremely thin small outline package; no leads; 6 terminals; body 1 x 1 x 0.5 mm SOT891

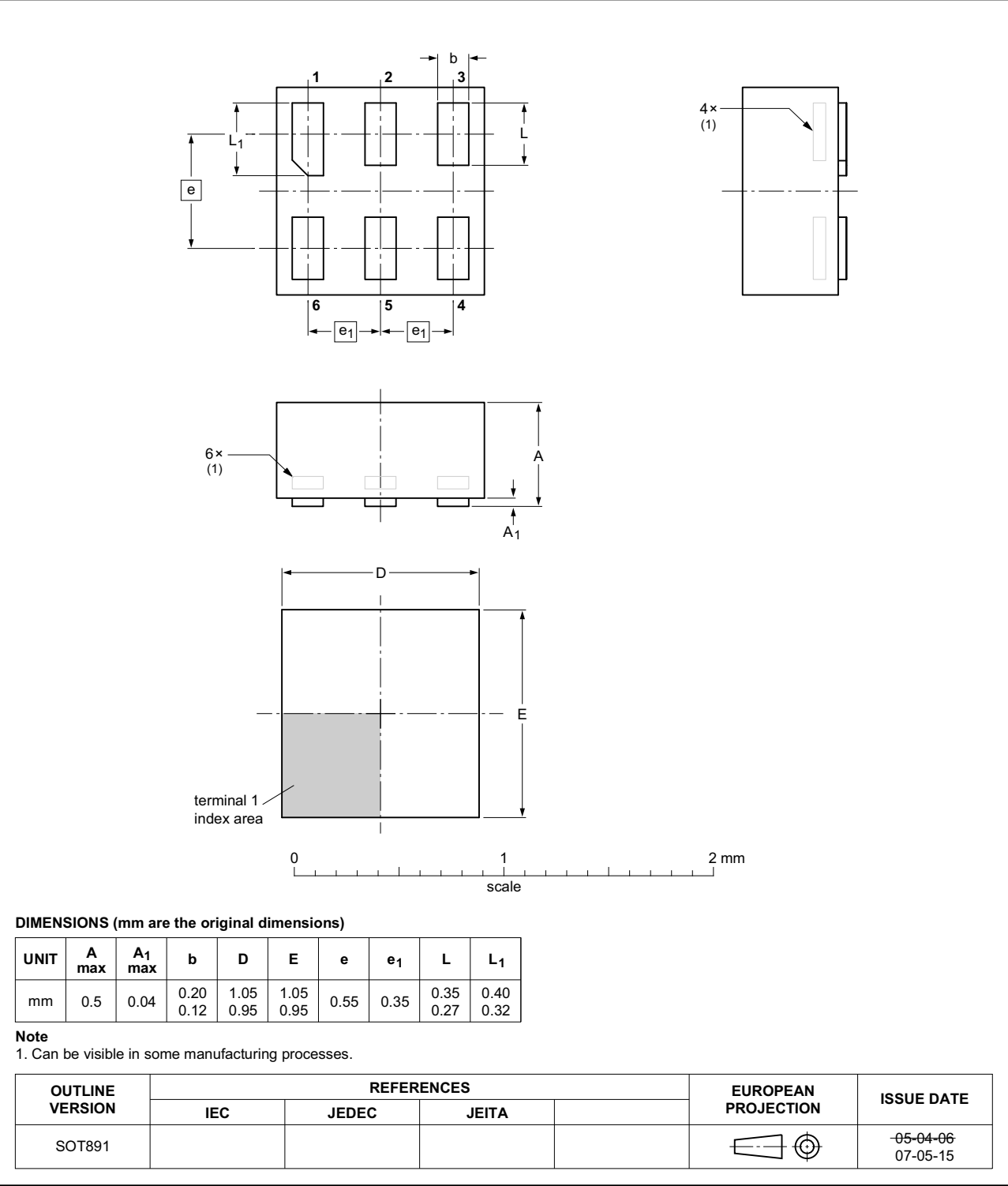
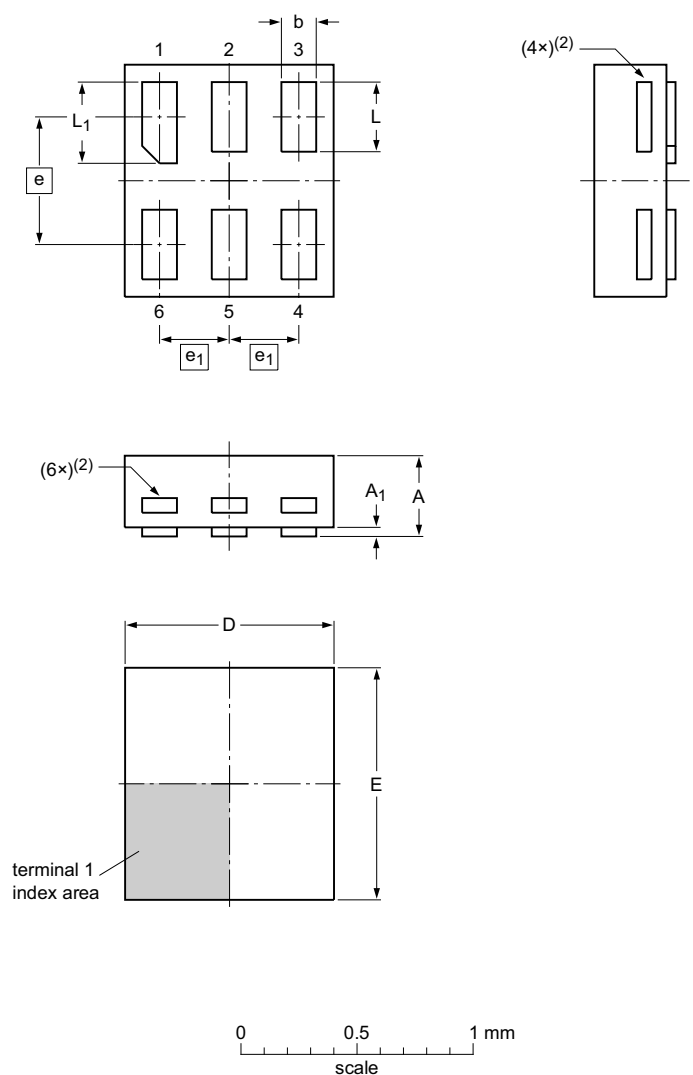


Fig 18. Package outline SOT891 (XSON6)

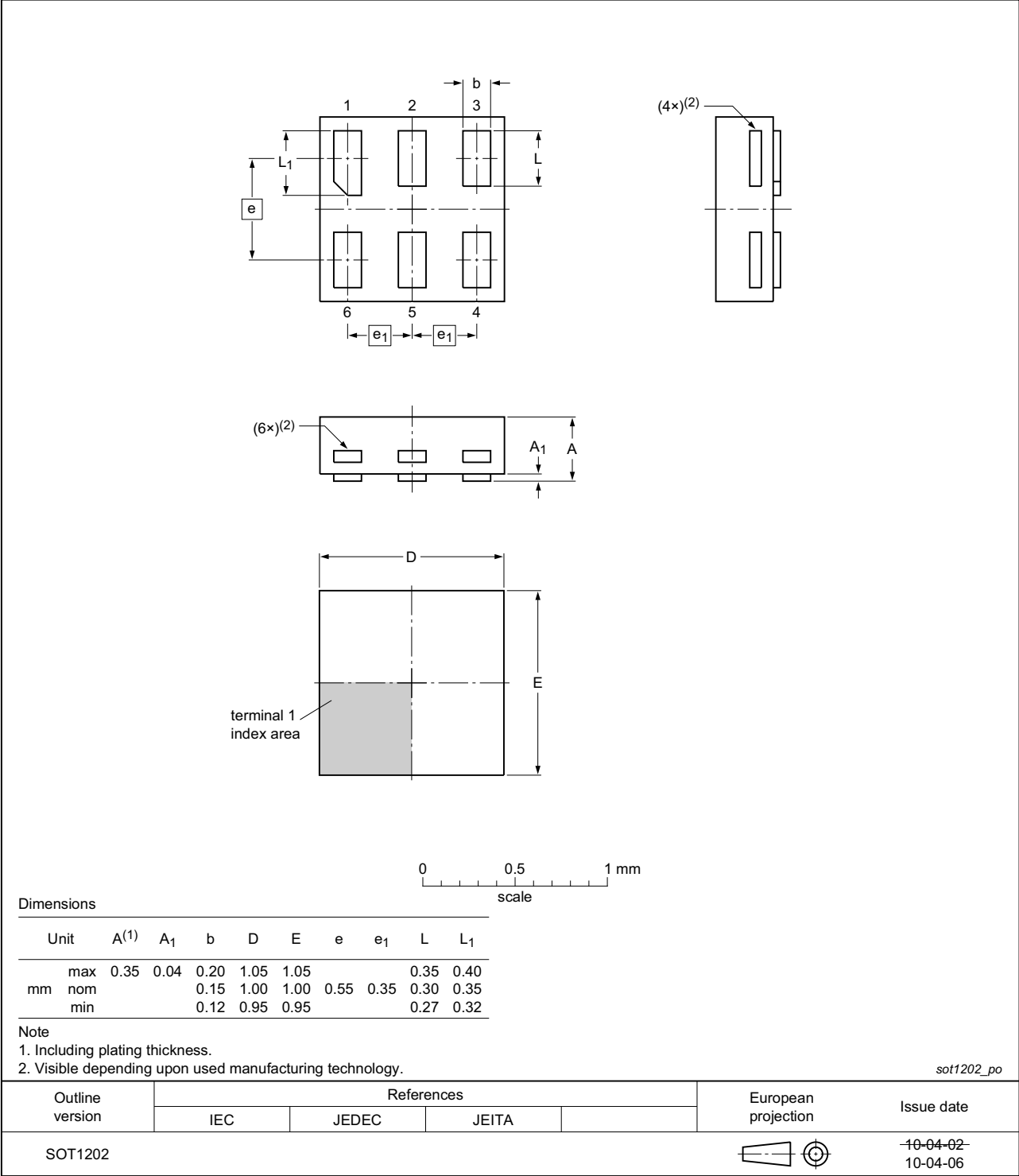


Fig 20. Package outline SOT1202 (XSON6)
