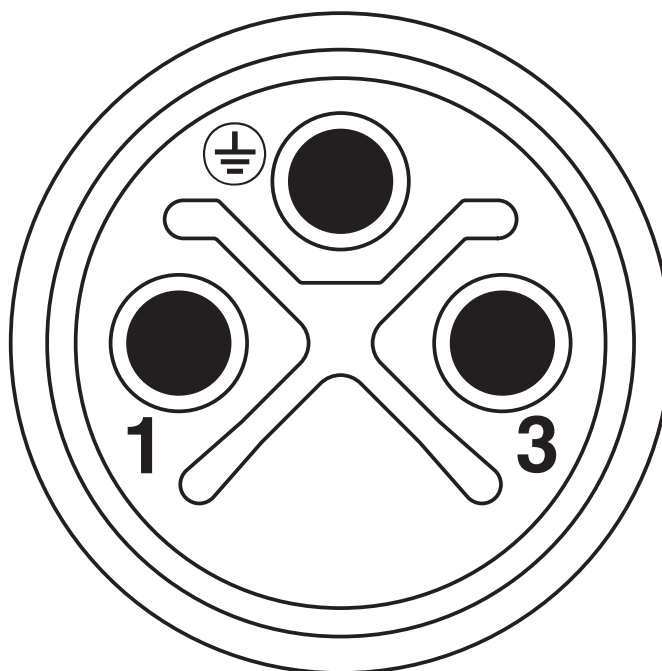

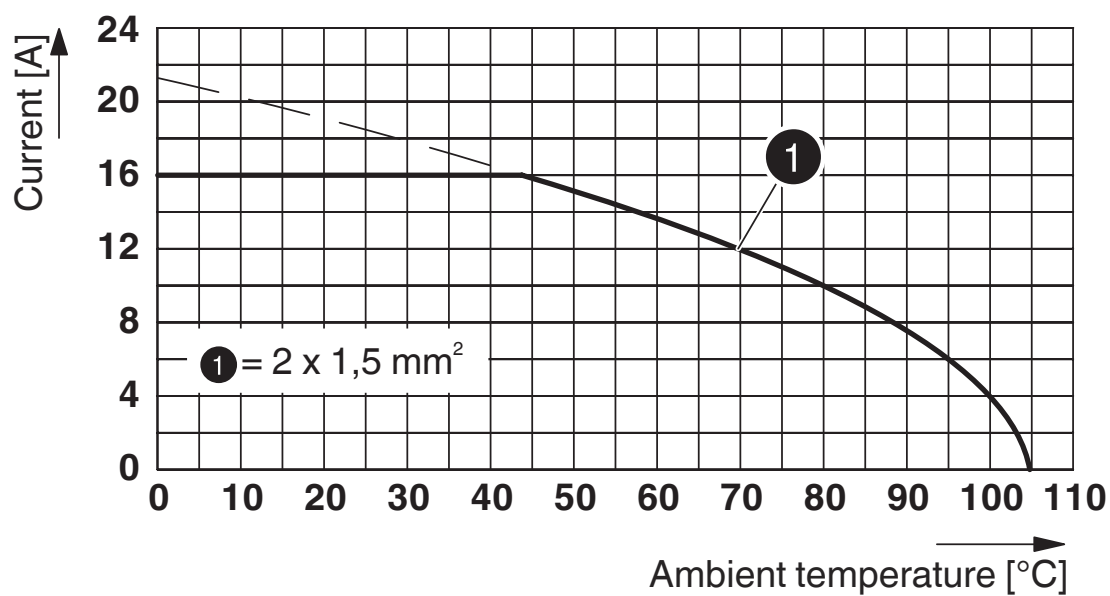

Derating diagram

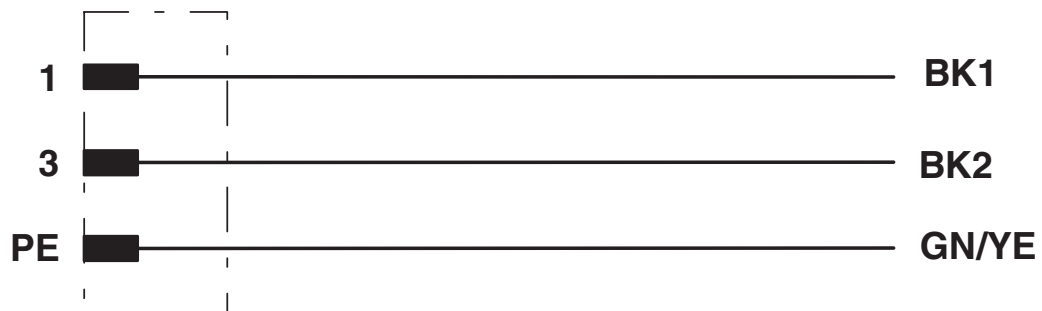
