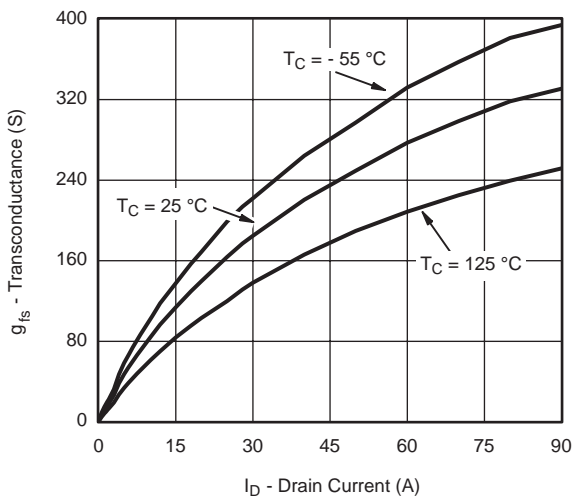

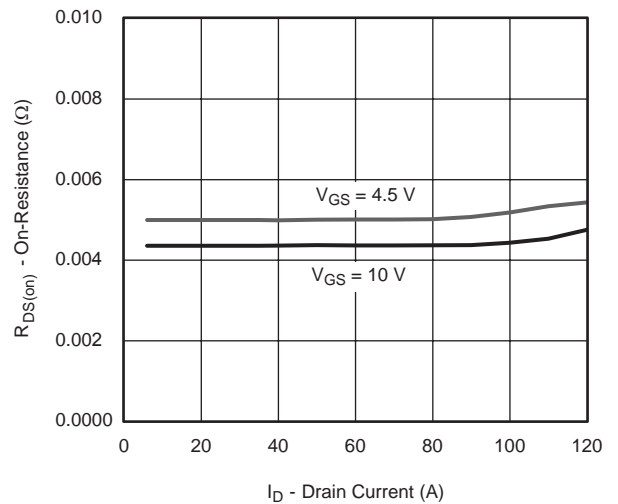

Transfer Characteristics



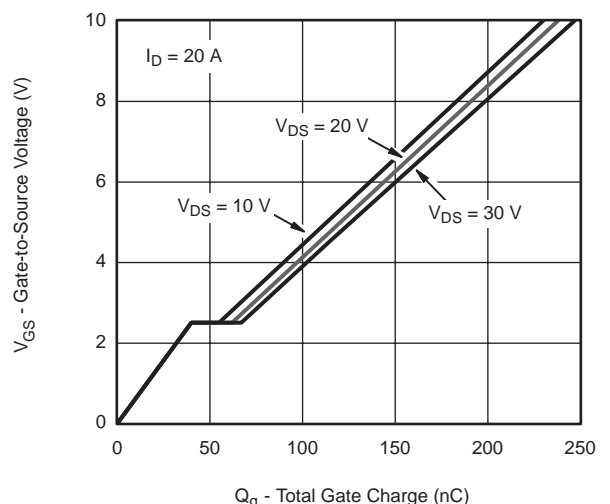
Transconductance
