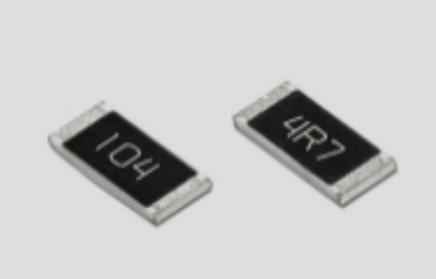

Surface Mount Resistors(1)

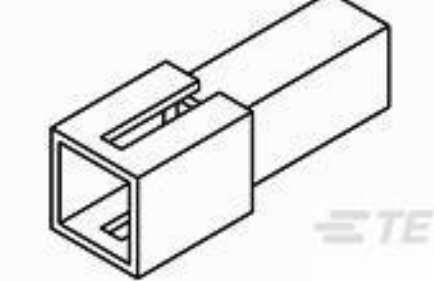
