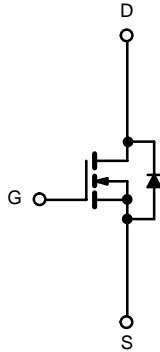

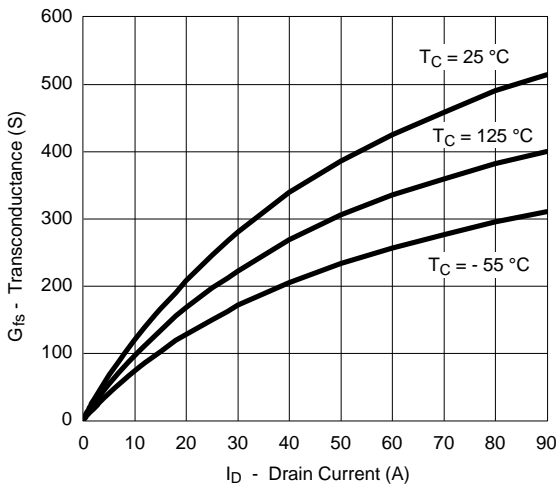

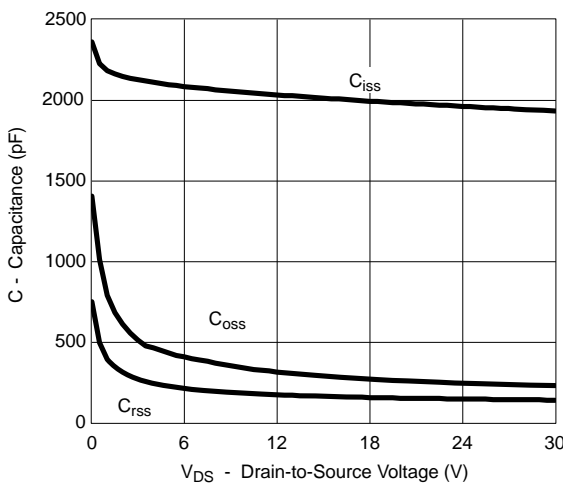
Transfer Characteristics

$R_{DS(on)}$ vs. Drain Current

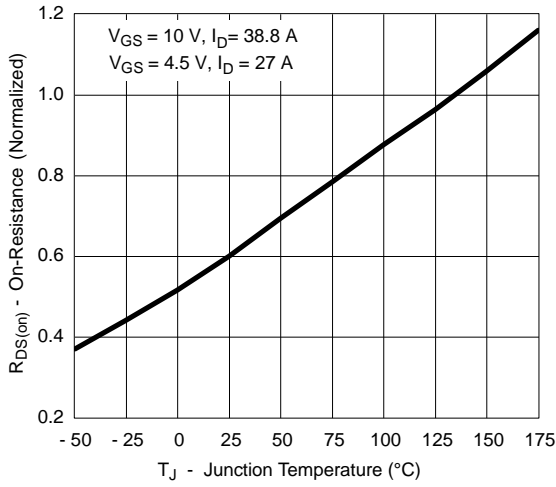


Capacitance

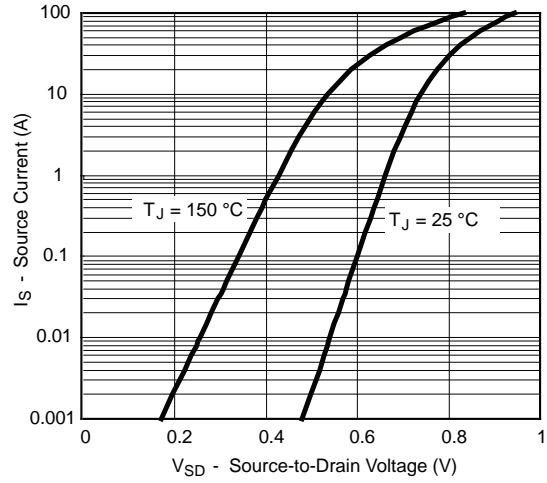

Threshold Voltage

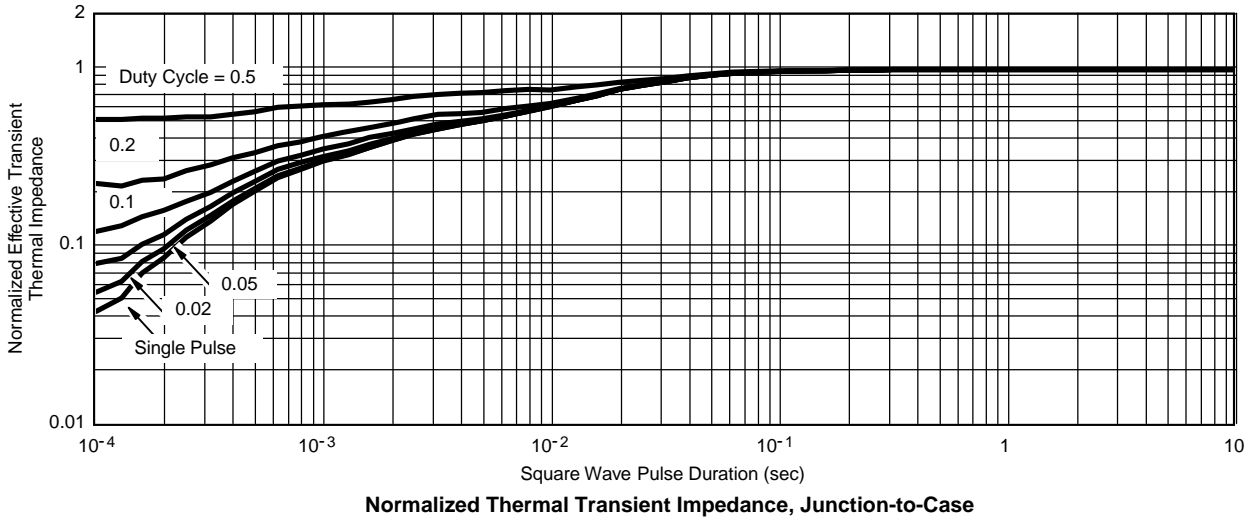

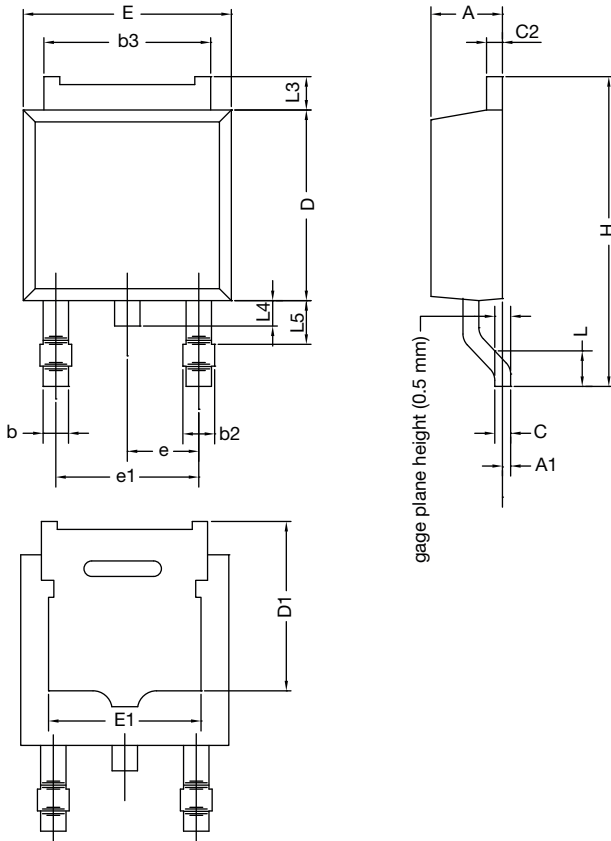

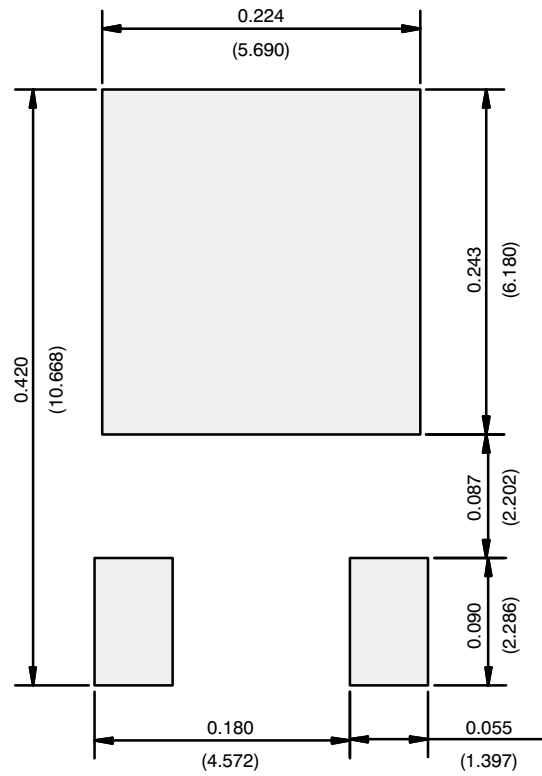
