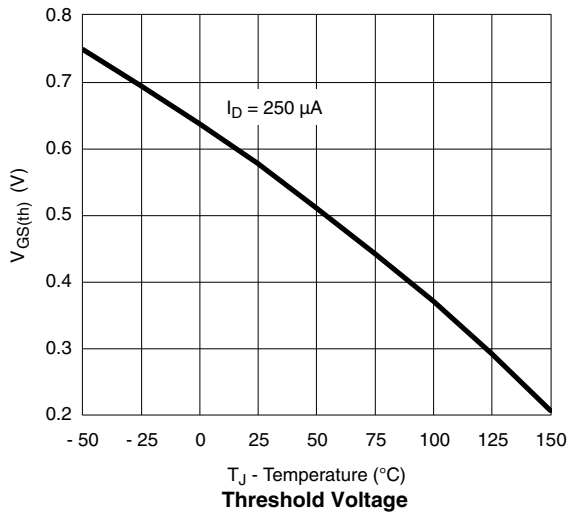

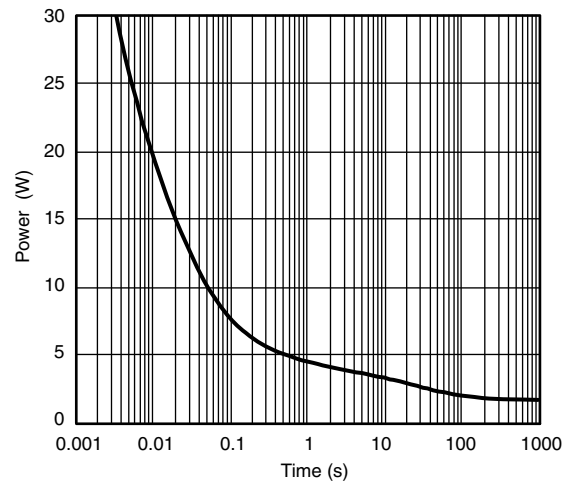
Source-Drain Diode Forward Voltage



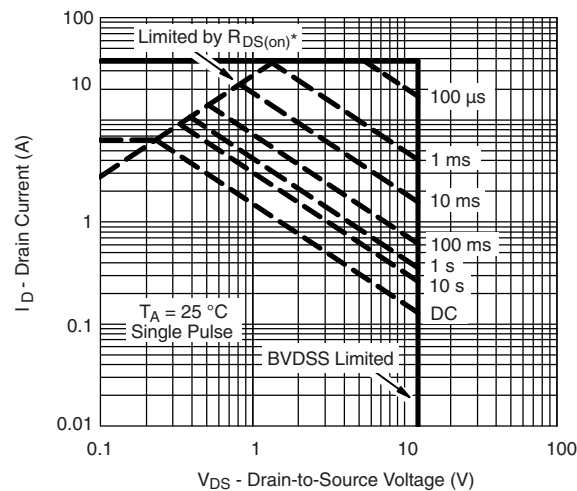
On-Resistance vs. Gate-to-Source Voltage



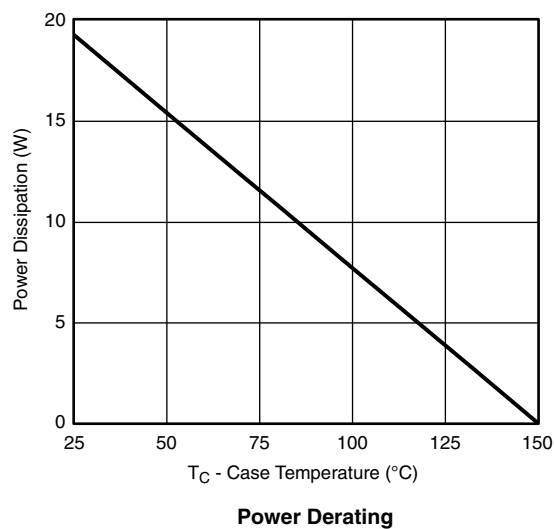
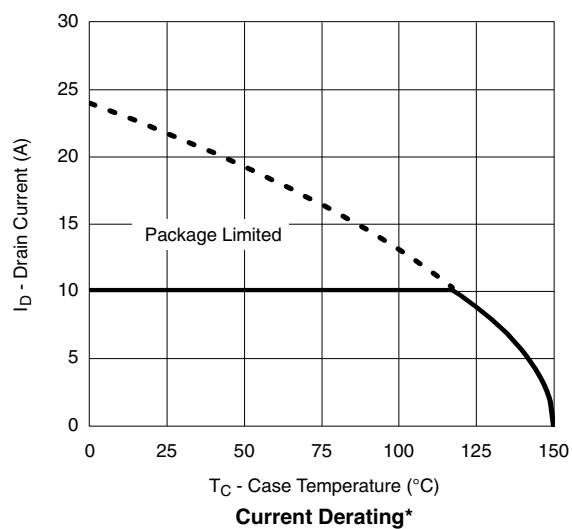

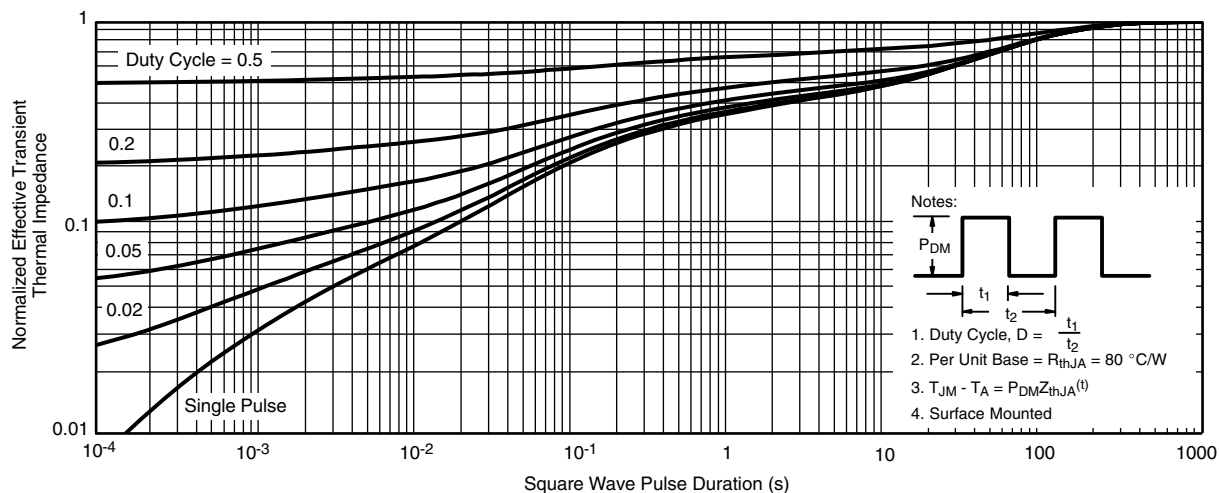
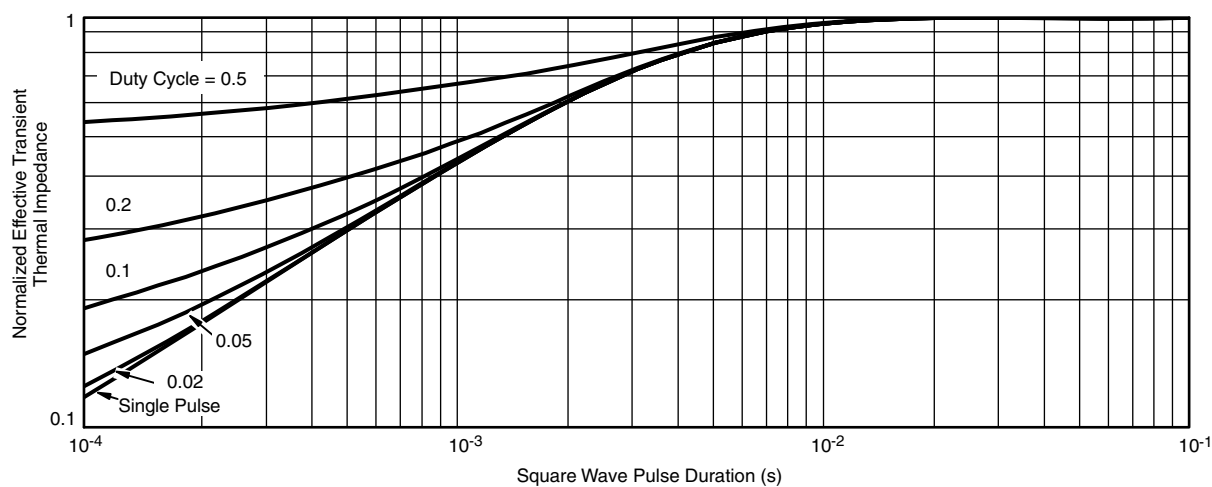
Single Pulse Power, Junction-to-Ambient

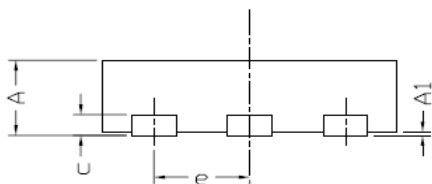

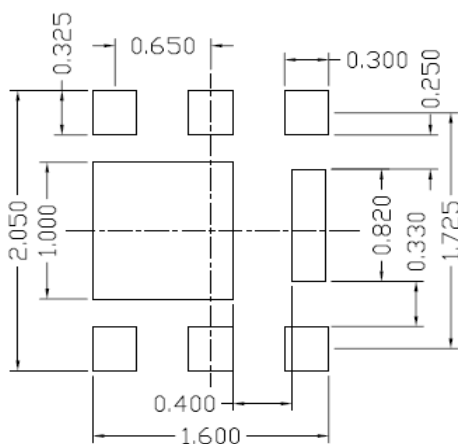
DFN2x2 _6L_EP1_S PACKAGE OUTLINE

RECOMMENDED LAND PATTERN



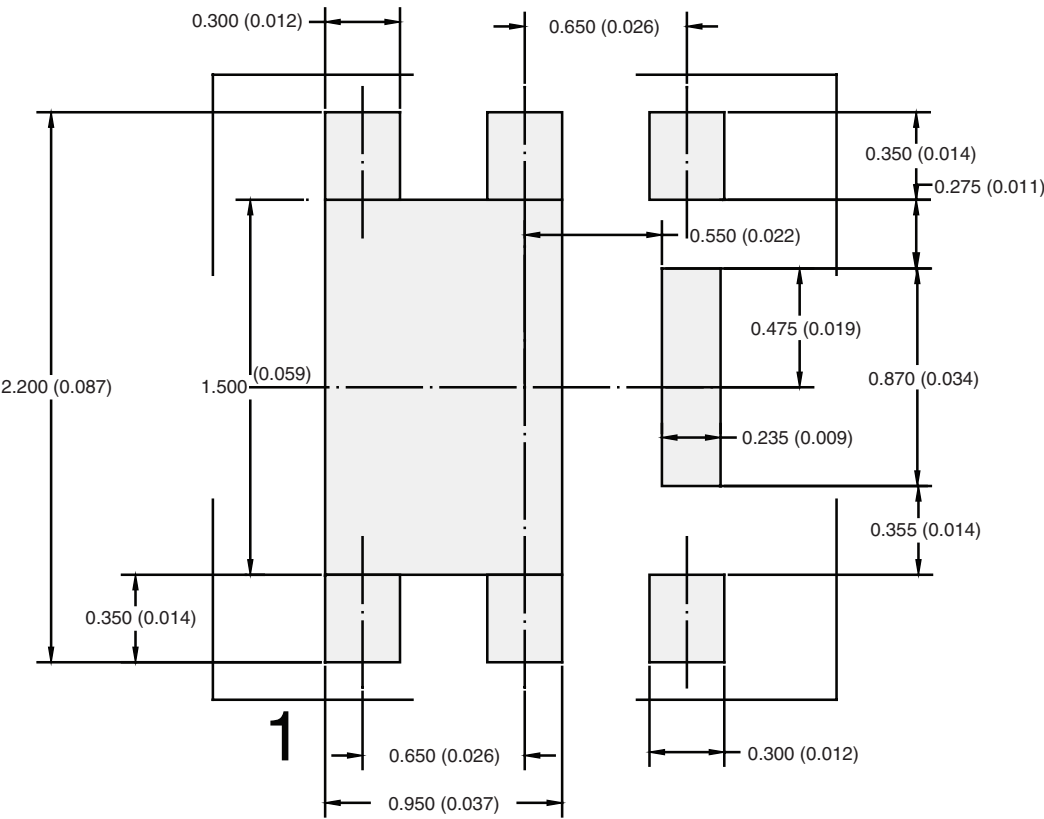
