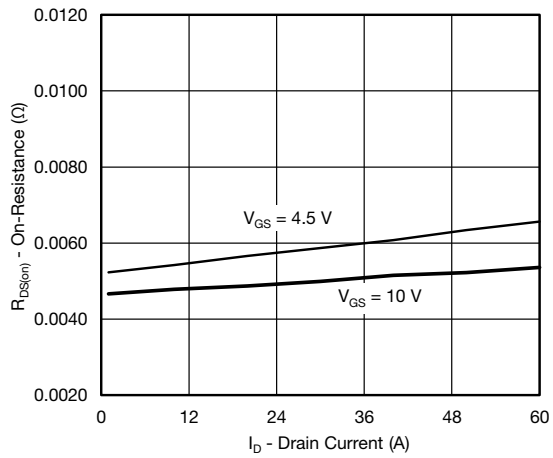

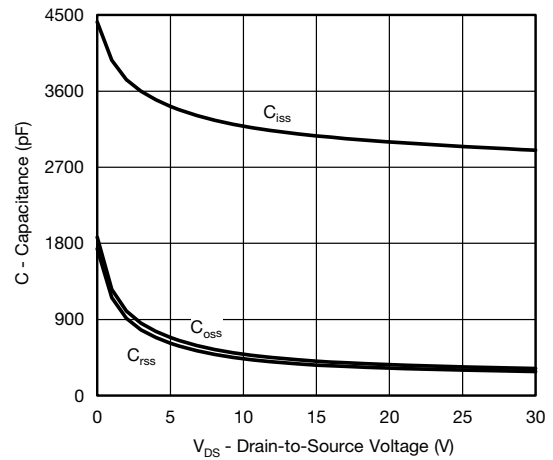

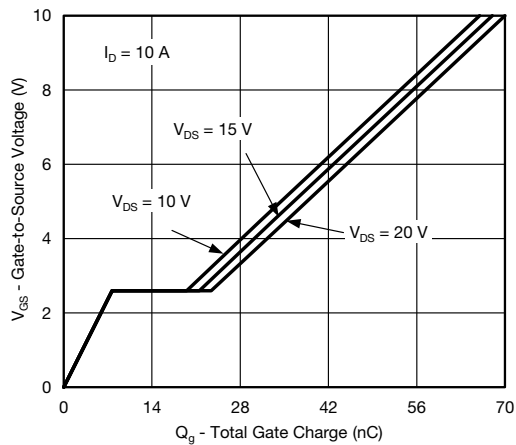

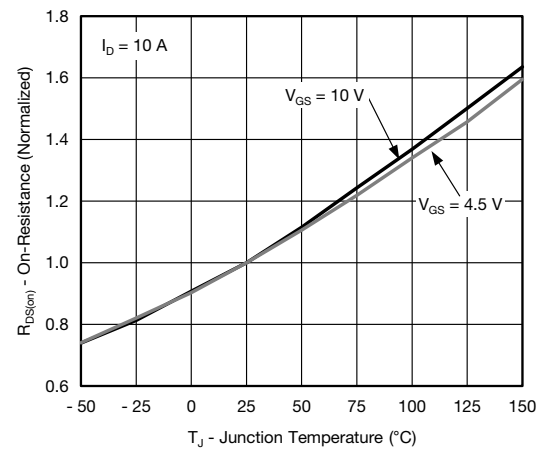
On-Resistance vs. Drain Current and Gate Voltage



Capacitance

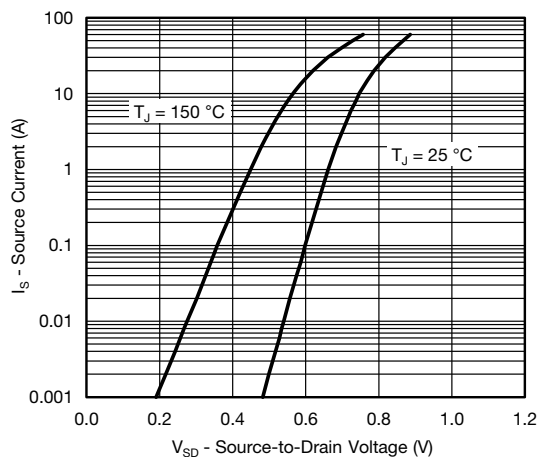


Gate Charge

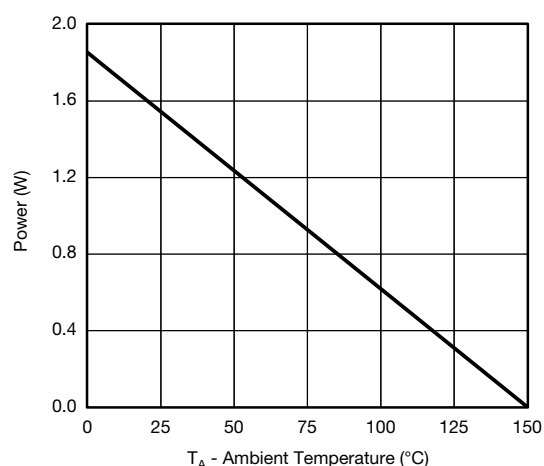
Single Pulse Power, Junction-to-Ambient



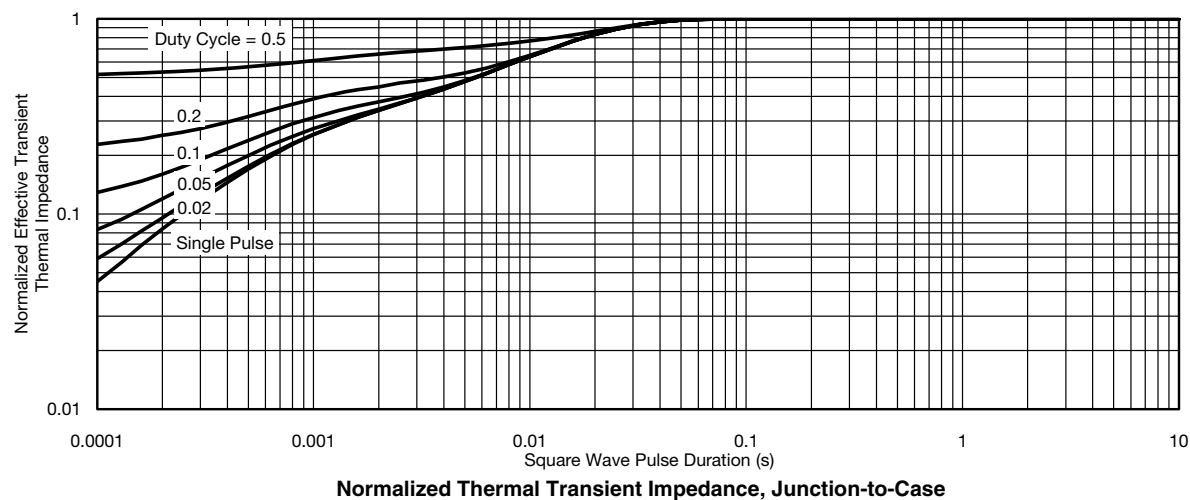

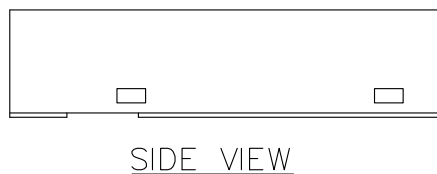
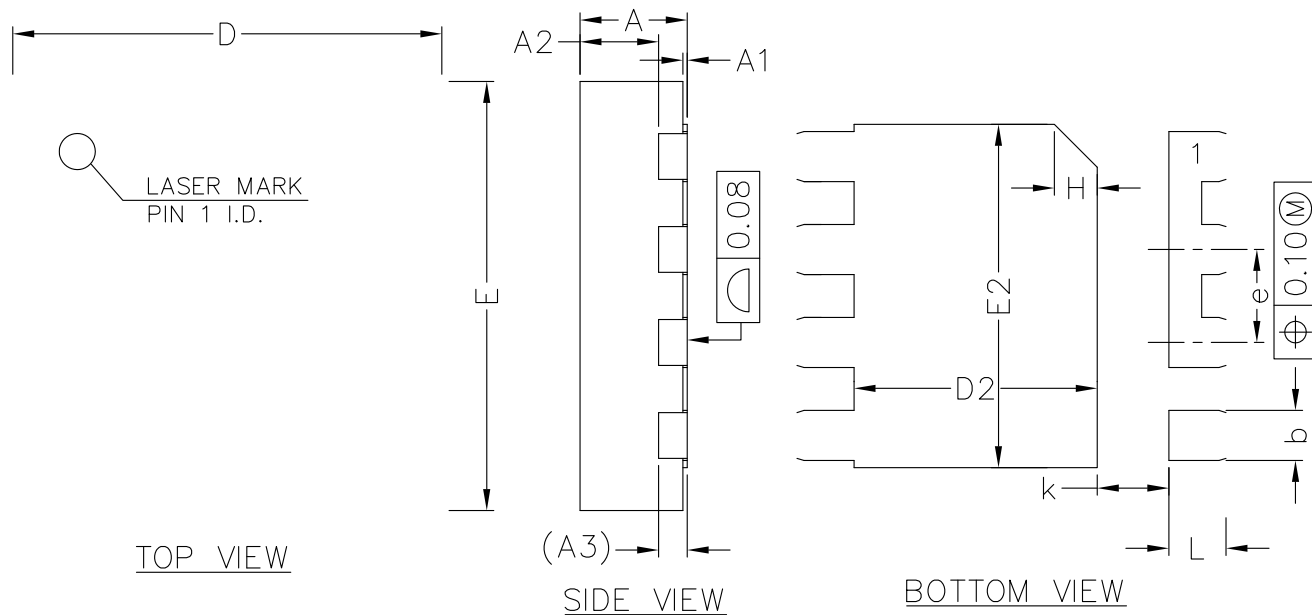
