Circuit diagram



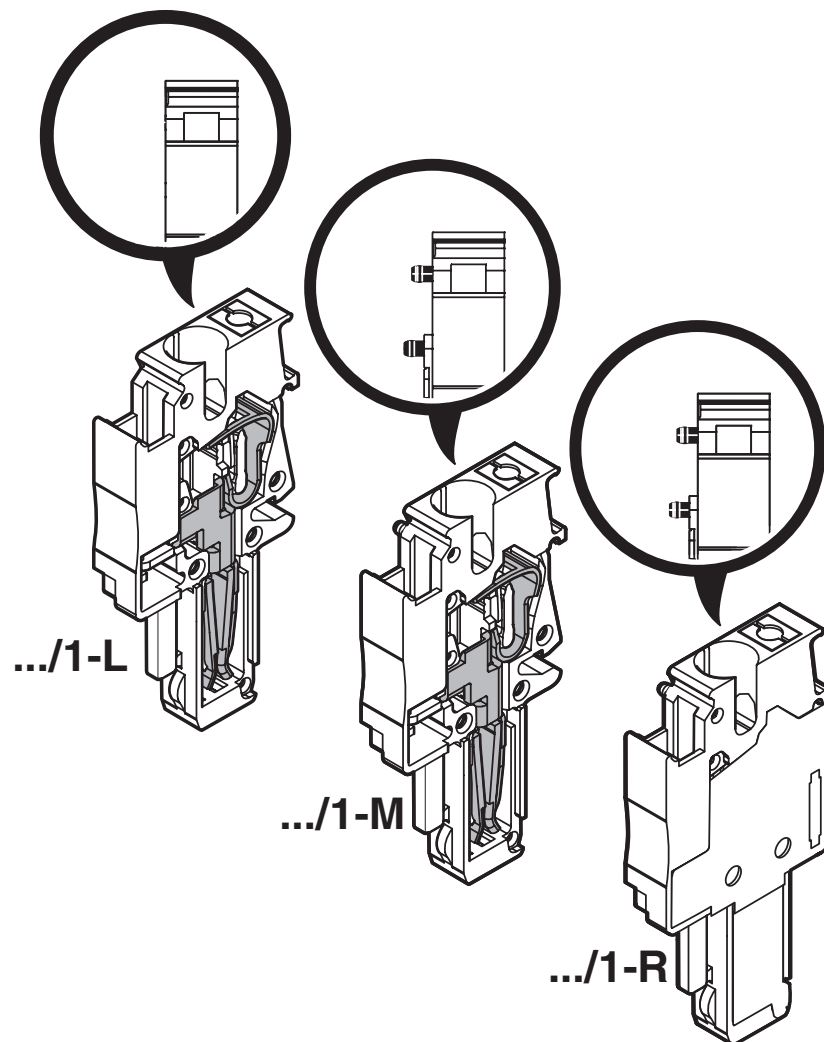
