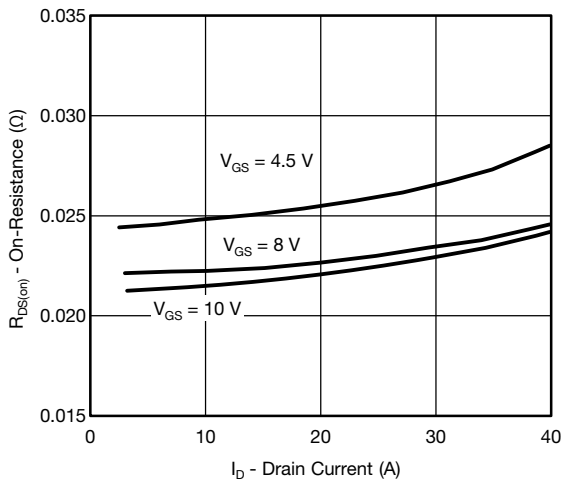

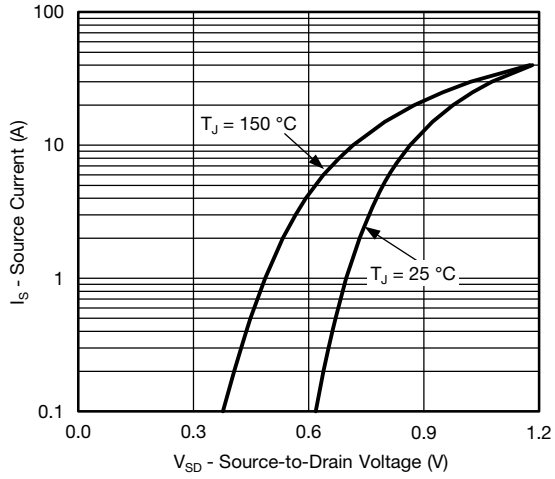

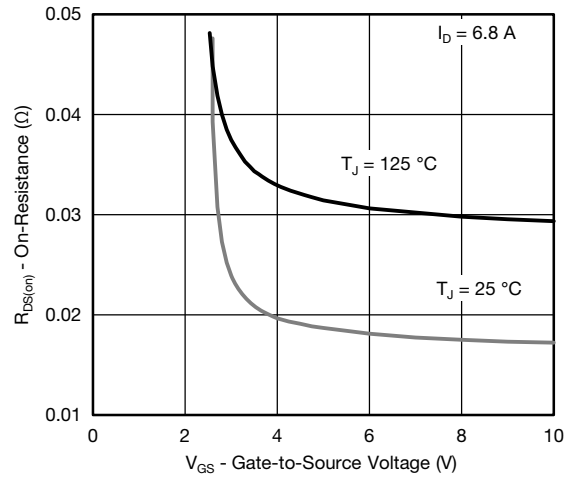

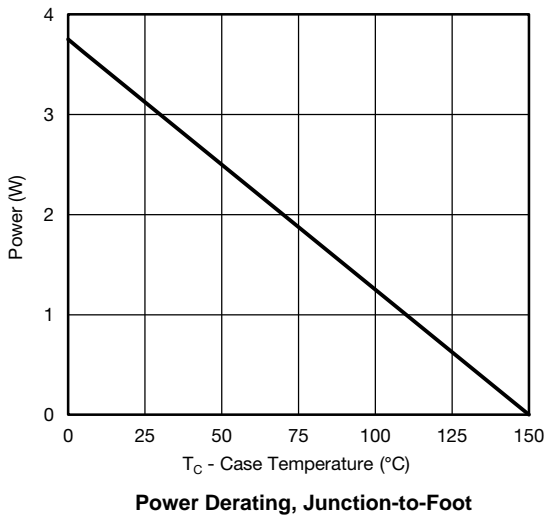


Single Pulse Power, Junction-to-Ambient

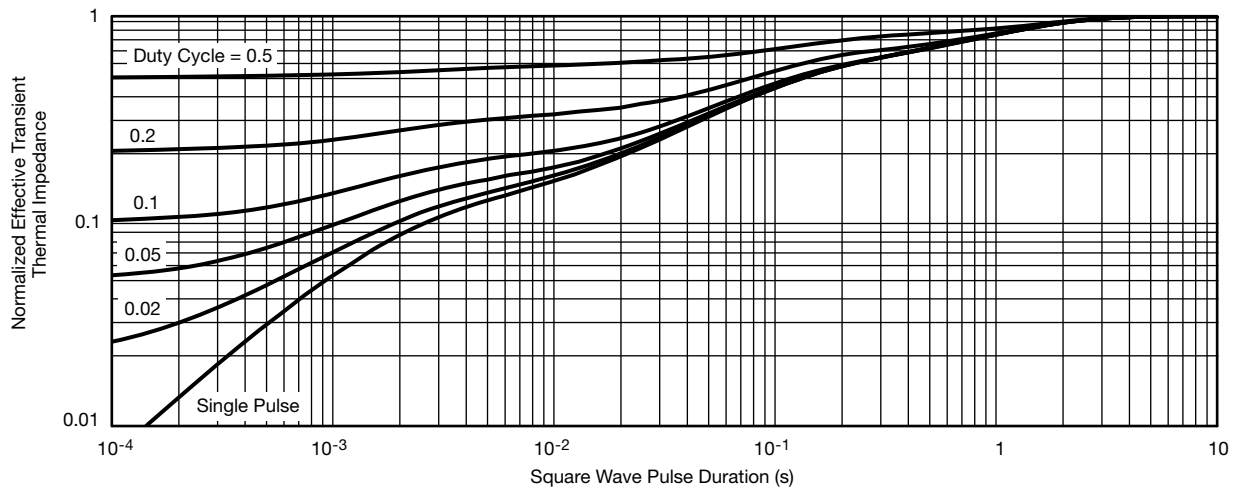

**Normalized Thermal Transient Impedance, Junction-to-Ambient**

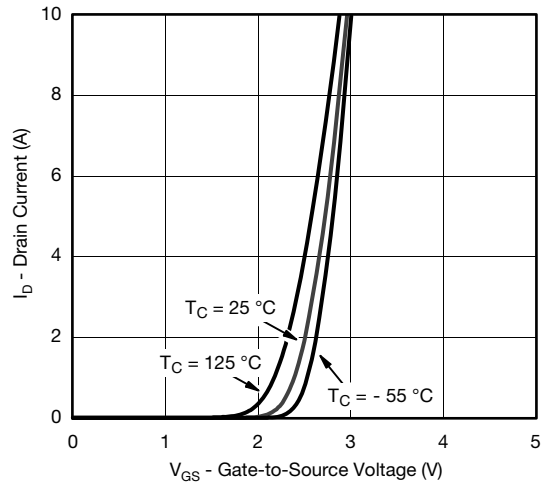


**Normalized Thermal Transient Impedance, Junction-to-Foot**

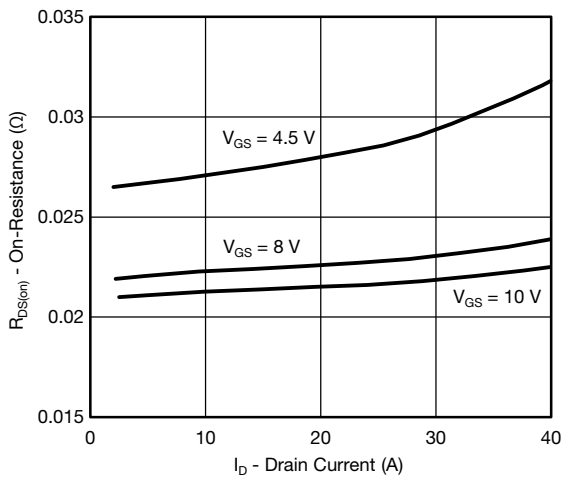

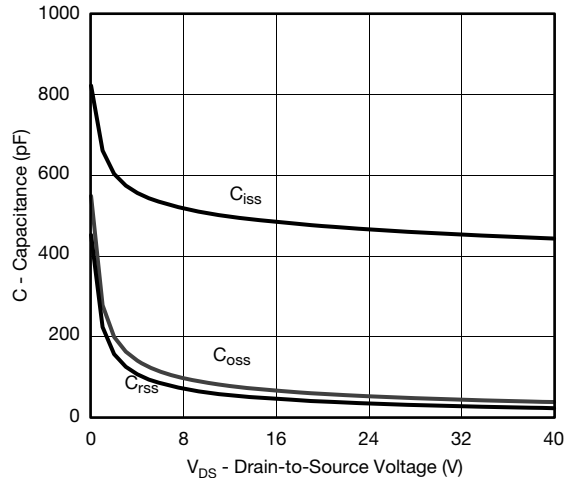

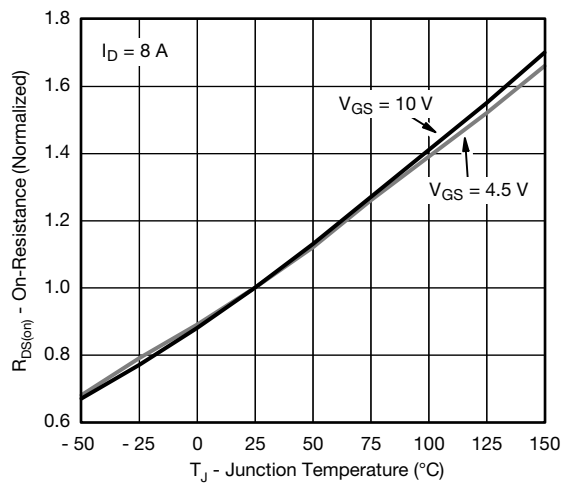

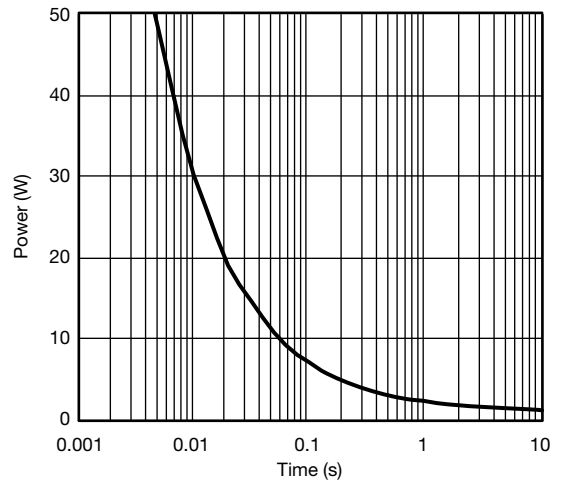
Source-Drain Diode Forward Voltage

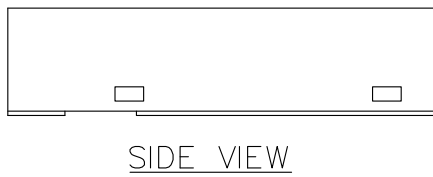
