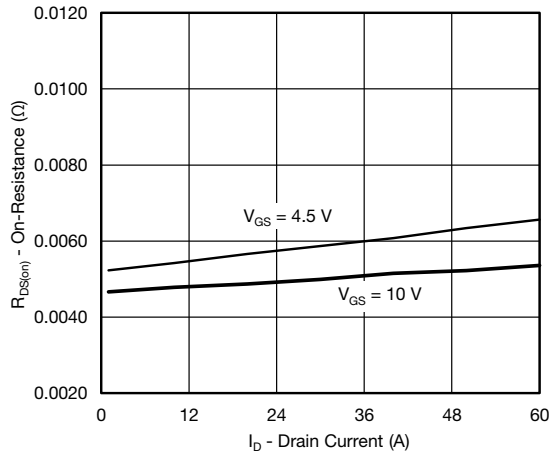

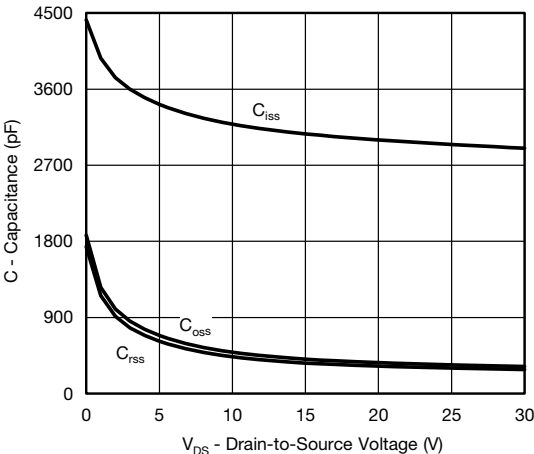

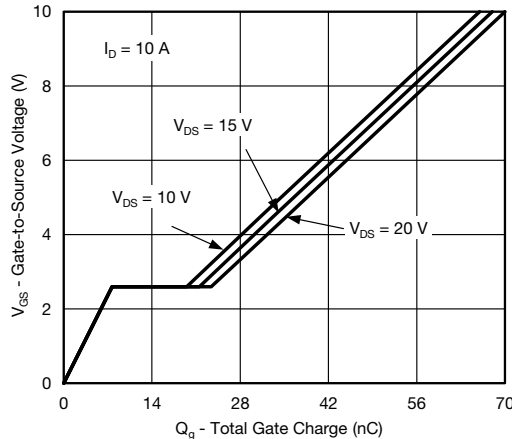

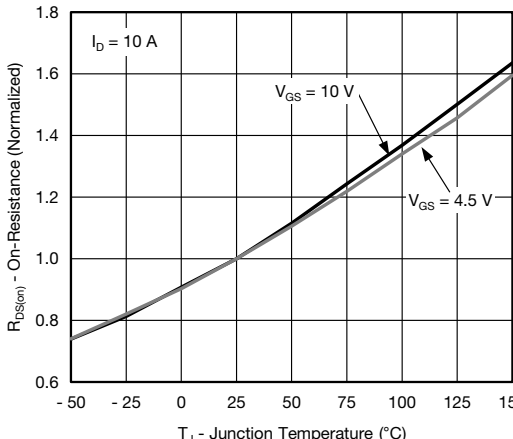
On-Resistance vs. Drain Current and Gate Voltage



Capacitance

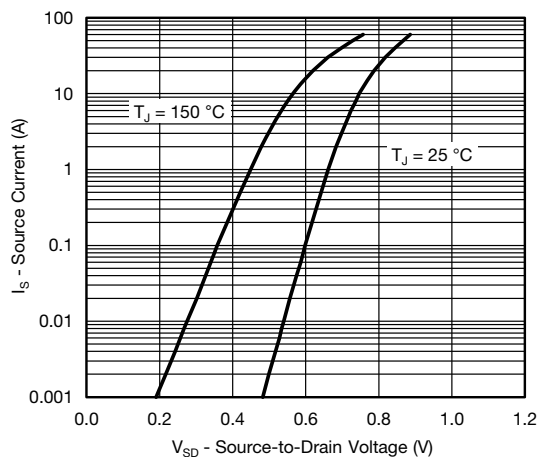


Gate Charge

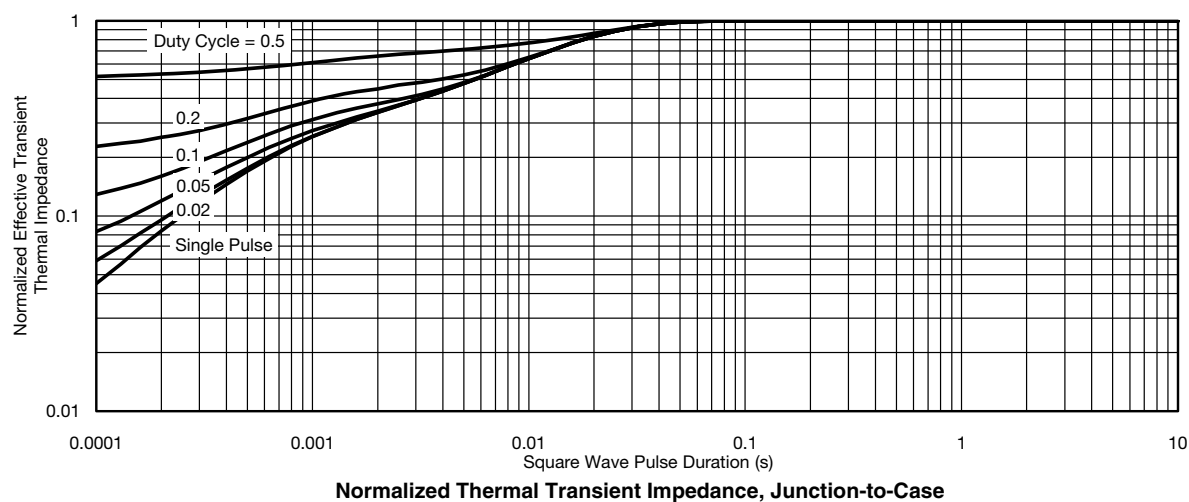


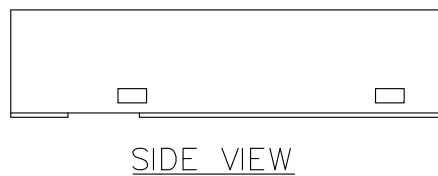
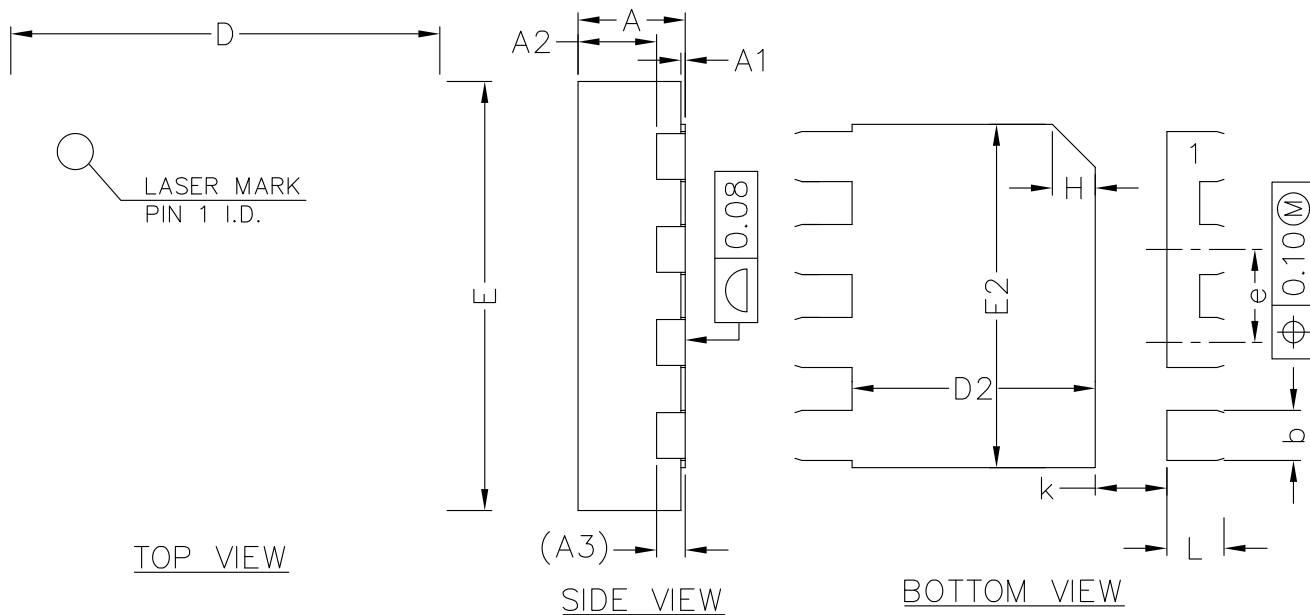
Safe Operating Area, Junction-to-Ambient
