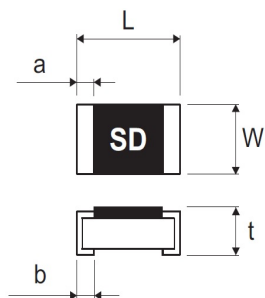

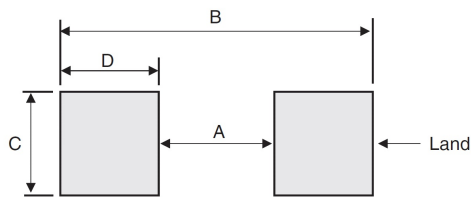

●Land pattern example



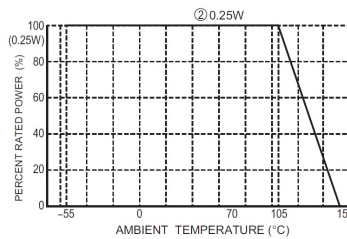
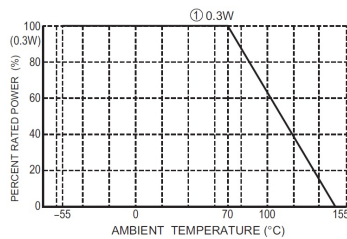
