

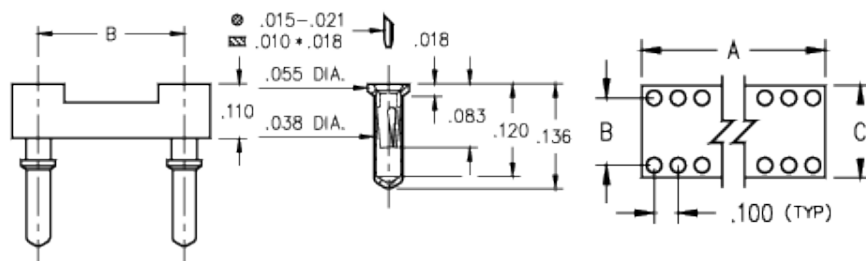

Properties of BERYLLIUM COPPER:

- Chemical composition: Cu 98.1%, Be 1.9%
