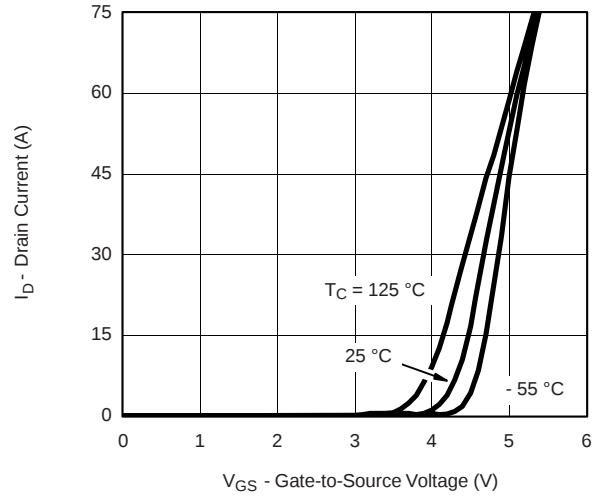

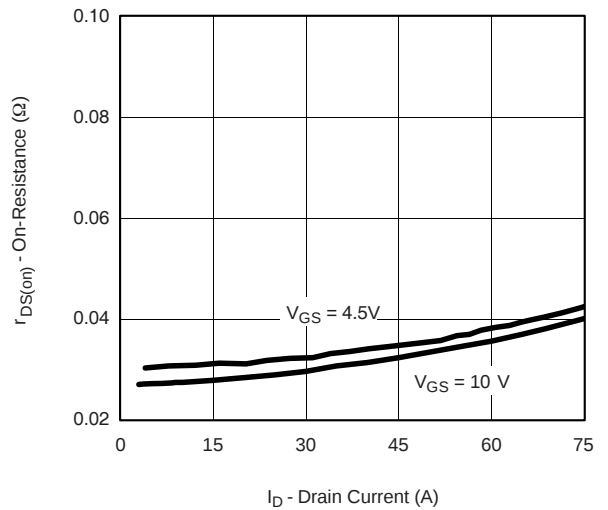

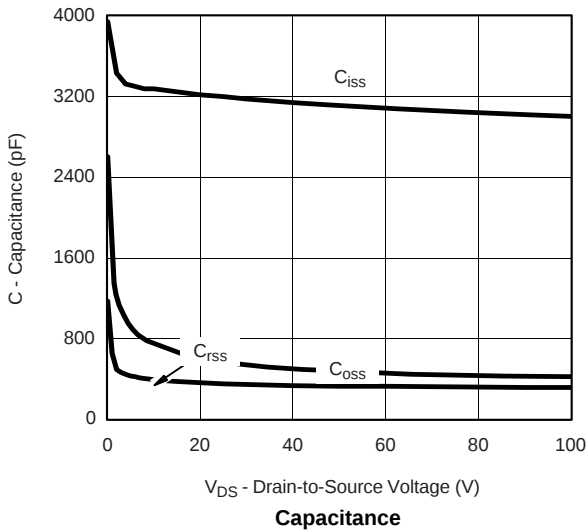

Avalanche Current vs. Time

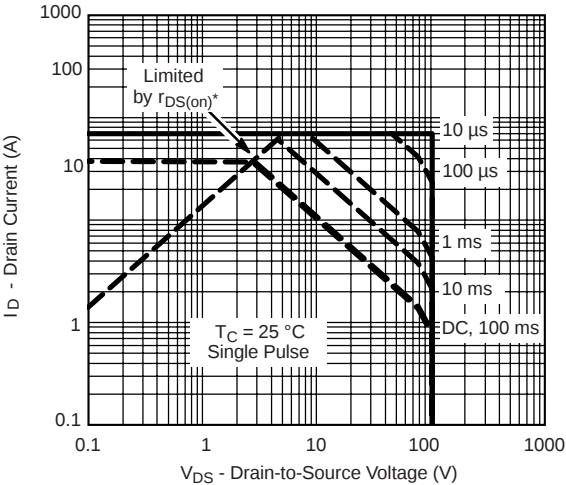


Drain-Source Breakdown Voltage vs. Junction Temperature

Maximum Avalanche and Drain Current vs. Case Temperature

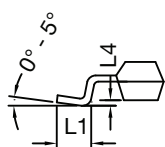

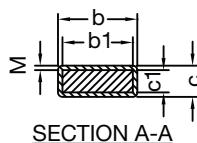


Normalized Thermal Transient Impedance, Junction-to-Case
