

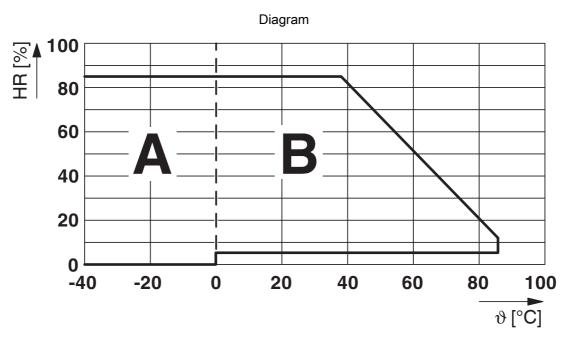
Curve B


