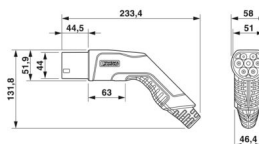

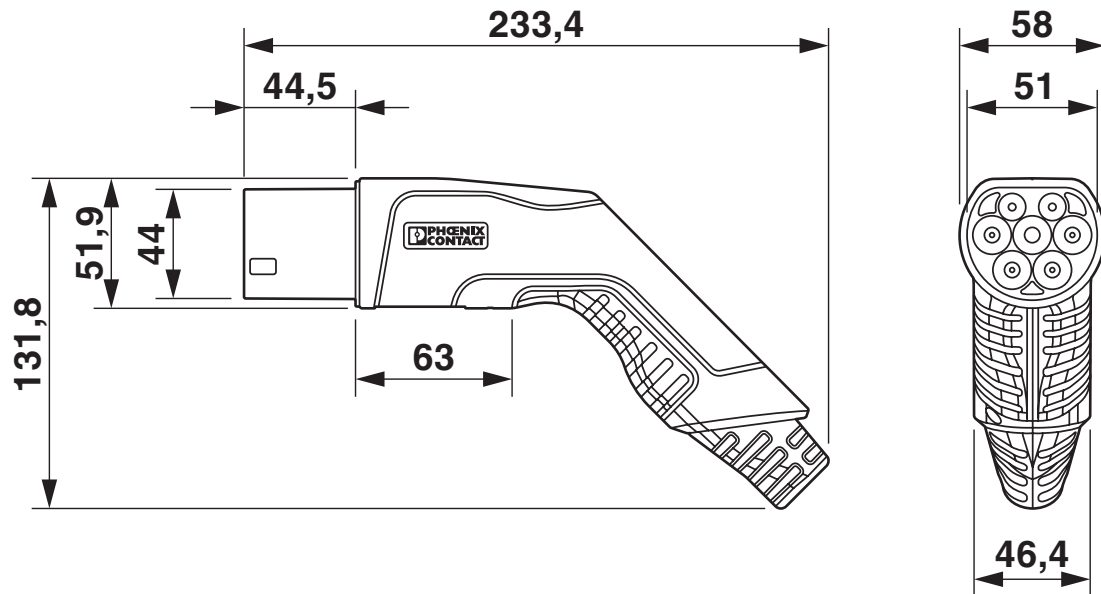

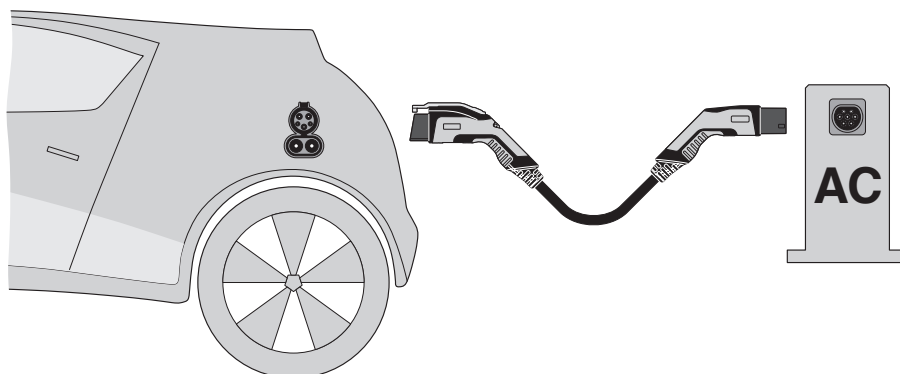

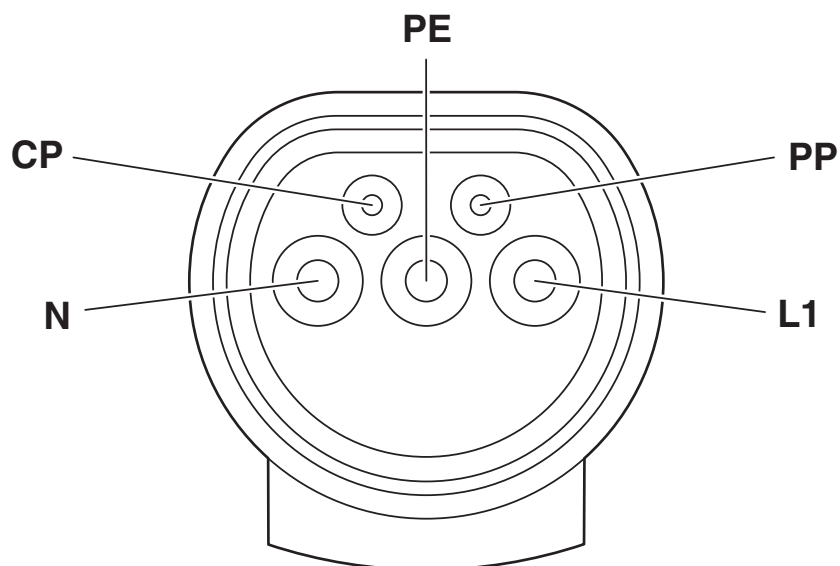

Schematic diagram



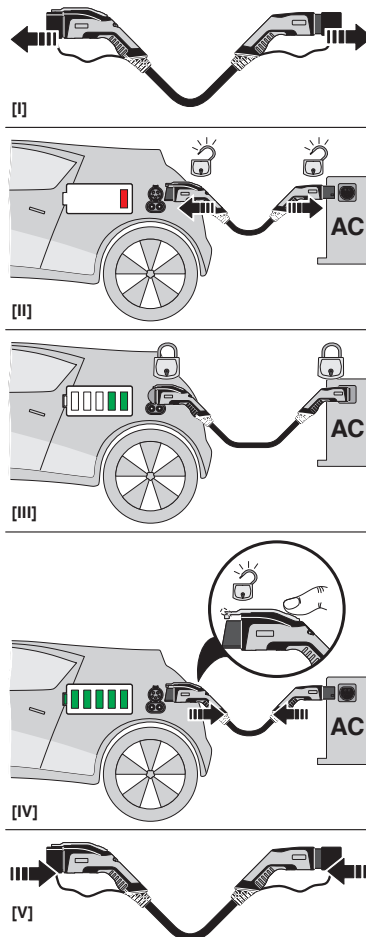
Type 2 infrastructure plug pin assignment

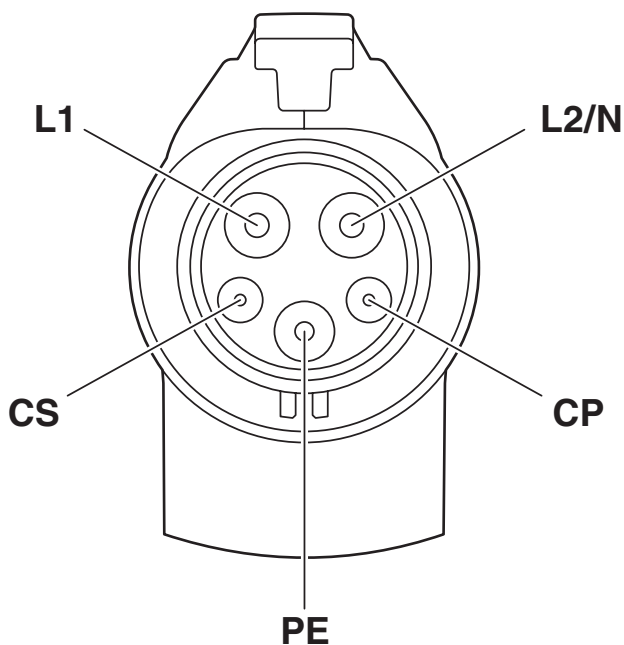

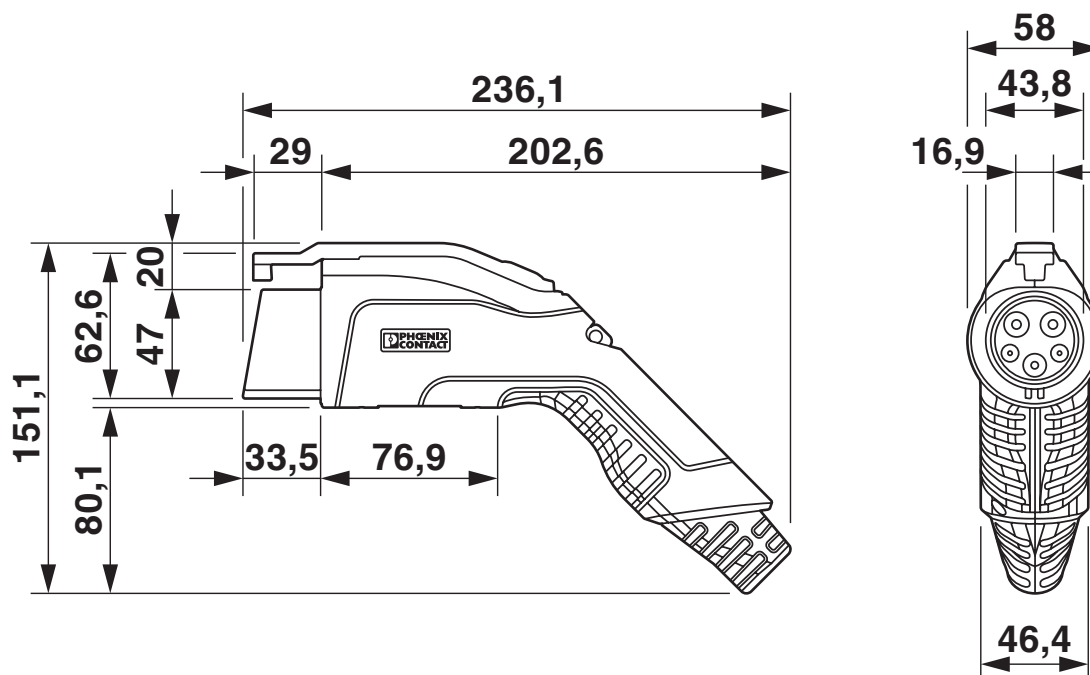
