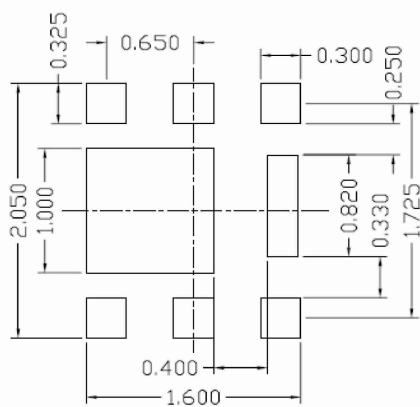
Normalized Thermal Transient Impedance, Junction-to-Ambient

RECOMMENDED LAND PATTERN



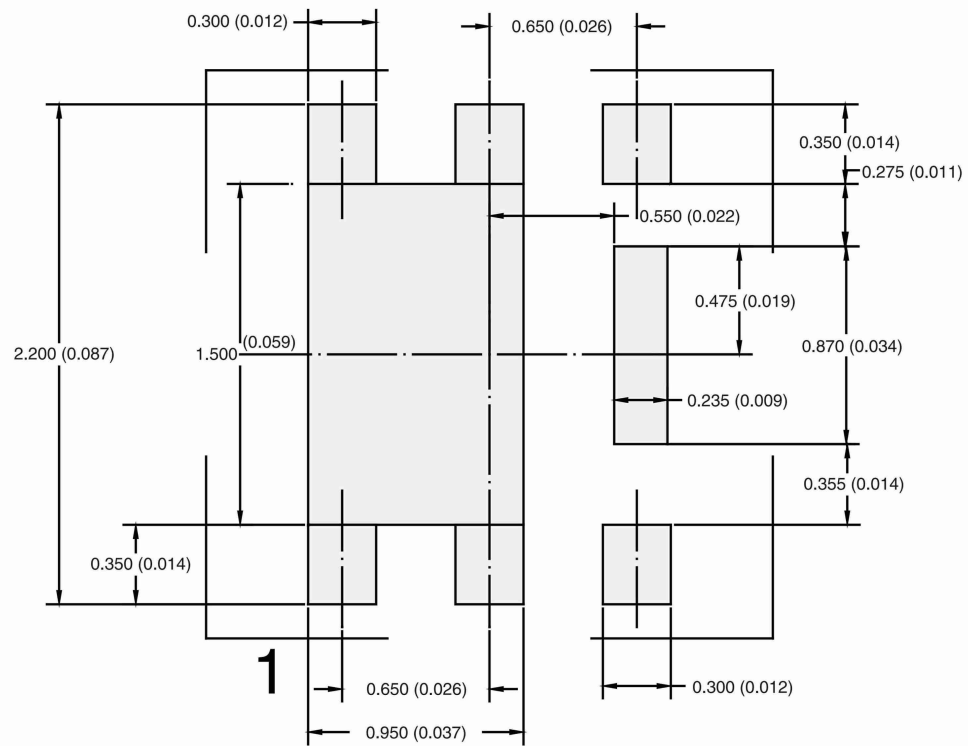
