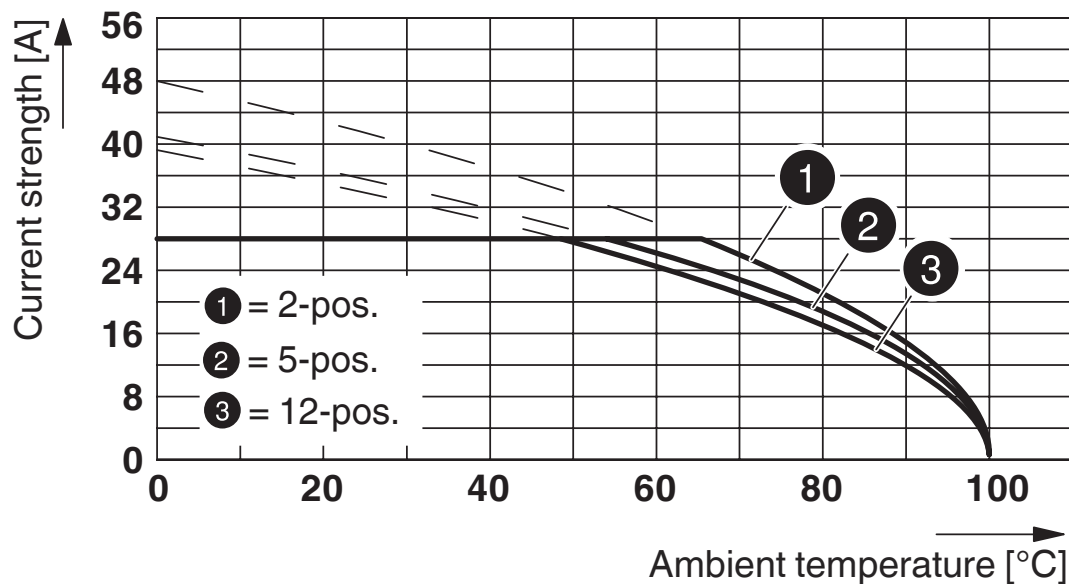

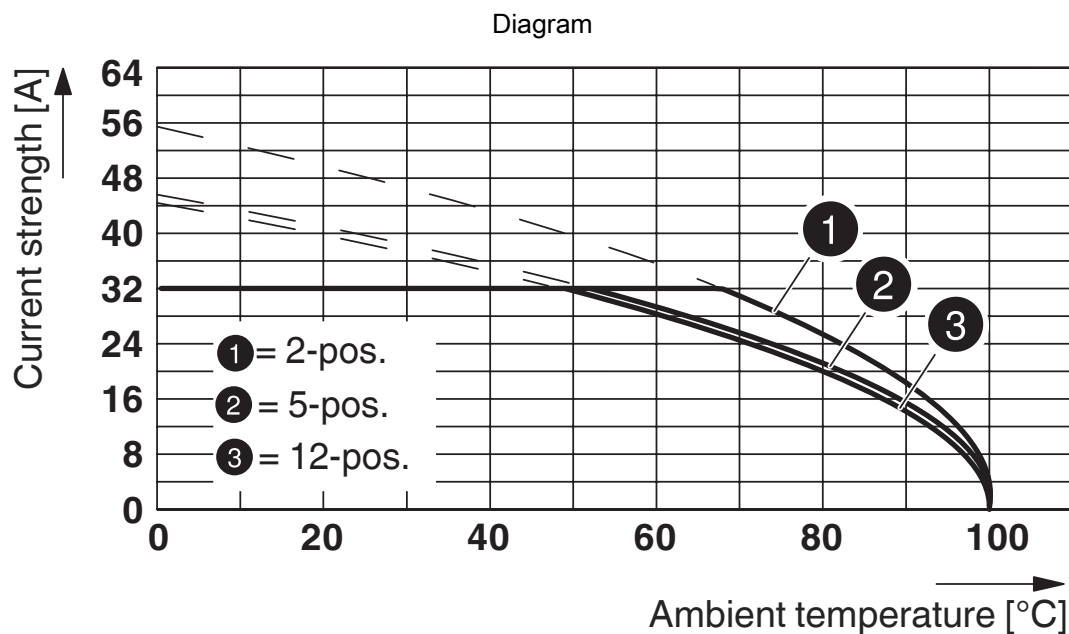

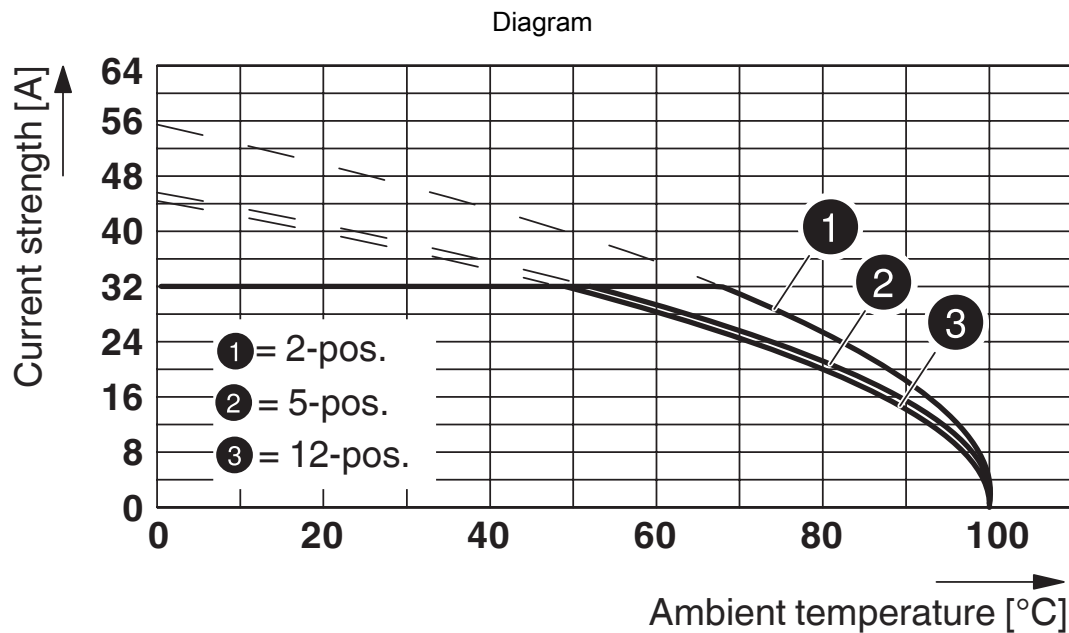

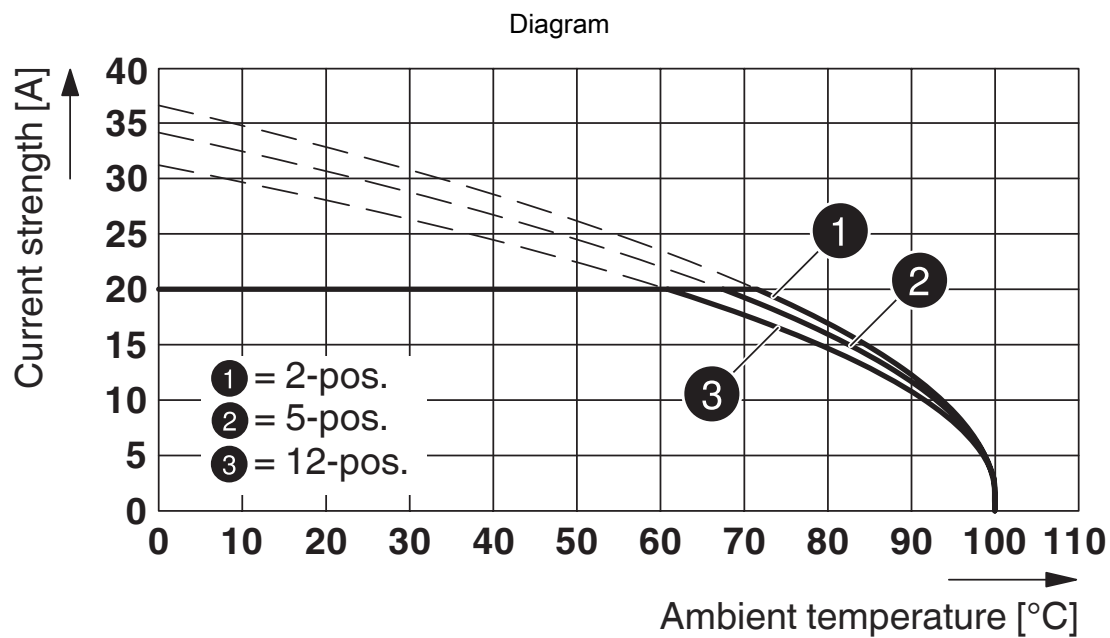
Derating curve for: PC 5/...-STF1-7,62 with PCV 4/...-G-7,62

Conductor cross-section: 6 mm²

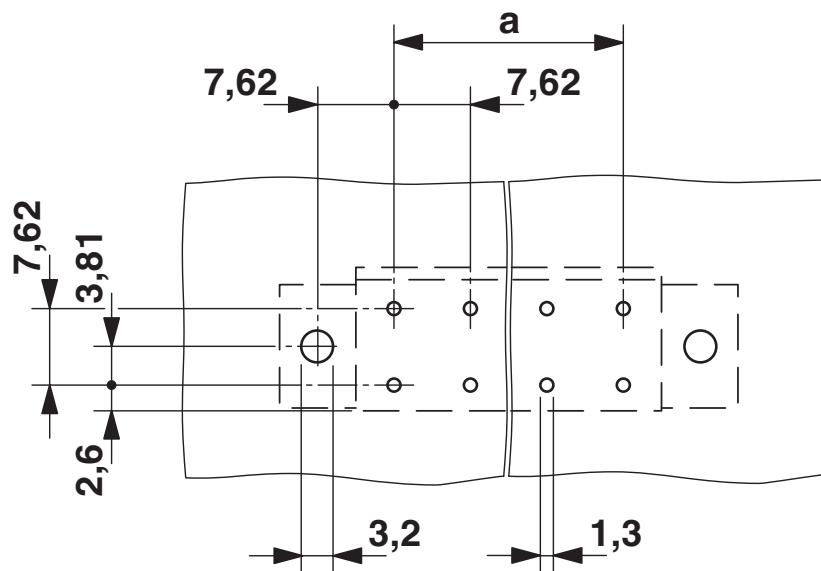


Derating curve for: PC 5/...-STF1-7,62 with PCV 4/...-G-7,62
