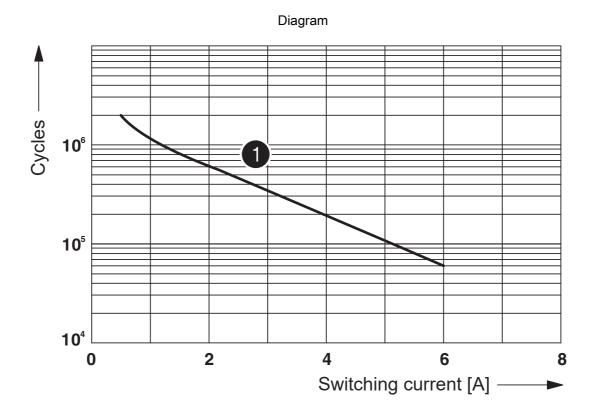

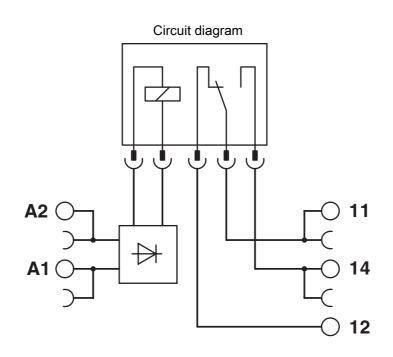

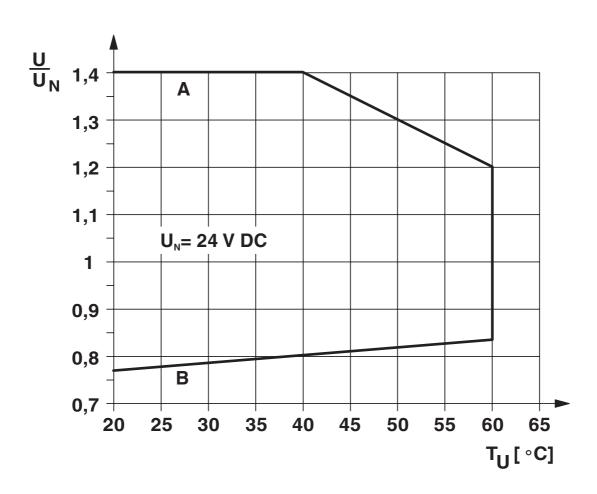

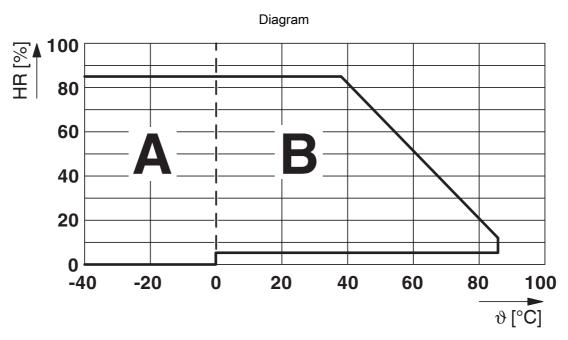
# Curve A Maximum permissible continuous voltage $U_{max}$ with limiting continuous current on the contact side (see relevant technical data) Curve B
